## 2023 Civic Partner Annual Report

### **PURPOSE**

This report provides Council and Calgarians with a summary of the results that Civic Partners achieved with The City's investment of over \$136 million in operating funding in 2023. The report is part of the accountability measures in place for Civic Partners in alignment with the *Investing in Partnerships Policy* (CP2017-01).

#### PREVIOUS COUNCIL DIRECTION

The last accountability reporting for Civic Partners was the 2022 Civic Partner Annual Report (CD2023-0402) in 2023 May and the 2022 Civic Partner Audit Report (AC2023-0414) in 2023 June.

## **HIGHLIGHTS**

- This report includes a detailed attachment for each of the 20 Civic Partners with an
  operating grant from The City in 2023 (Attachments 4 through 23) organized by line of
  service. Each Partner attachment includes a summary cover sheet with a Results Based
  Accountability snapshot and detailed information collected in a standard template that
  includes key results, performance measures and other highlights.
- In 2023, Civic Partners leveraged over \$136 million in operating grants from The City including \$7.4 million in one time-funding to support the delivery of targeted programs and services to Calgarians, advance City strategies and contribute to the operation and management of City-owned assets.
- Civic Partners support and enhance results under nine services in the One Calgary Service
  Plans and Budgets. They effectively multiply The City's investments with other resources to
  enhance quality of life for Calgarians and contribute to a vibrant economy and community.

 The City's Civic Partners. The 2023 Civic Partner Audit Report (AC2024-0282) is a
 companion report that will be presented to Audit Committee on 2024 June 13.

### DISCUSSION

Each year, The City partners with external organizations to provide effective programs and services in targeted areas, develop and advance strategies and construct, manage and operate City-owned assets. The City makes its most significant investment of operating grant funding in "Civic Partners", a category of partner defined in the *Investing in Partnerships Policy* based on the level of investment.

This report is part of the accountability requirements for the 20 Civic Partner organizations that received operating funding in 2023. Each Civic Partner's relationship with The City and responsibilities and requirements are guided by the Partner's legal structure and agreements in place. Civic Partners are structured as a mix of wholly-owned subsidiaries, legislated bodies and independent organizations.

The City's relationships with Civic Partners are mutually beneficial and focus on achieving agreed-upon results for Calgarians. In 2023, The City's investment in the Civic Partners included in this report was over \$136 million in operating grants including \$7.4 million in one-time funding. The City also invested \$17 million in capital grants for lifecycle of City-owned assets managed and operated by these Partners and \$7 million for one-time capital projects (Attachment 2). Overall, Civic Partners effectively leveraged The City's investments through earned revenue, donations, volunteers, grants, and other resources.

#### 2023 Results:

- Calgary Economic Development enhanced Calgary's economic resilience by supporting the creation or retention of more than 7,000 jobs and attracting \$734 million in investment.
   Tourism Calgary attracted meetings, conventions and sport and cultural events that contributed more than \$225 million in direct economic impact. The Calgary TELUS Convention Centre hosted 226 events that contributed over \$110 million in economic impact. Platform Calgary delivered programming to 1,670 clients and the 27 companies in the Platform Incubator program raised more than \$8.5 million to support their growth.
- Arts Commons experienced a 41 per cent increase in venue usage and continued to undertake proof of concept work.
- Overall, cultural attractions partners drew over 2.6 million visitors, with over approximately
   1.5 million visitors to the Calgary Zoo, 618 thousand to Heritage Park, 12 thousand to Fort Calgary, 428 thousand to TELUS Spark and 52 thousand to the Hangar Flight Museum.
- Calgary Arts Development Authority invested over \$10.7 million in arts organizations and \$3.6 million in individual artists and collectives. Contemporary Calgary saw continued growth in its attendance levels to over 55 thousand visitors and focused on partnering to share space and resources.
- Civic Partners enhanced the social resilience of Calgarians by offering a broad range of community-based initiatives. The Calgary Public Library saw its highest ever circulation

and had 6.7 million visits. The Central Library celebrated its fifth birthday and has welcomed more than five million visitors since opening. **Silvera for Seniors** welcomed 219 new residents to their supportive living housing for low-income seniors and 80 per cent of its residents reported feeling connected to their local neighbourhood. **Vibrant Communities Calgary** released *Beneath the Surface*, a report examining 50 indicators of well-being and partnered with the University of Calgary's School of Public Policy to explore the circumstances that put people at risk of homelessness.

- The MNP Community & Sport Centre hosted 50 events that brought more than \$4 million in economic impact and continued to be a hub for four community associations, downtown commuters and Calgarians from across the city. Sport Calgary continued to deliver results through partnerships with social agencies, community collaboratives and organizations in the sport, physical activity and recreation sector. Parks Foundation leveraged funding to support 122 community projects, including 30 new projects and awarded grants to 27 sport and community organizations. Heritage Calgary continued to see growth in the inventory of historical resources and supported Calgarians through events, walking tours, site visits, videos and research papers.
- In 2023, more than 9,000 Calgarians generously volunteered more than 211,000 hours with Civic Partners.

Attachments 4 through 23 include detailed templates submitted by each Civic Partner with a covering Results Based Accountability snapshot prepared by Administration and reviewed by each Partner. New sections in this year's template provided space for Civic Partners to report key results that advanced their organizational strategies, the qualitative impacts of their work, and highlights for the current year (2024).

Administration continues to work closely with Civic Partners to achieve results for Calgarians and this report is one tool that supports transparency and accountability for Council and Calgarians.

### **IMPLICATIONS**

#### Social

Civic Partners support a high quality of life for Calgarians by encouraging collaboration to reduce poverty and grow the local economy. They support entrepreneurs and operate cultural attractions that offer experiences and learning related to arts and culture, conservation, history and science. They help develop new parks and open spaces, support heritage conservation and offer opportunities to engage in sports and recreation. They enhance local arts and culture opportunities, support low-income Calgarians through access to programs including affordable housing for low-income seniors, offer community library services and support the vibrancy of local neighbourhoods. Within their individual operations they work to address and advance diversity, inclusion and equity, and advance Truth and Reconciliation.

#### **Environmental**

Civic Partners support environmental stewardship and community sustainability strategies including public education and awareness related to conservation, public spaces and natural resources. They continue to review their operational practices including facility maintenance to reduce consumption and overall environmental impact.

#### **Economic**

Civic Partners contribute to a high quality of life that is a foundation of a healthy and vibrant local economy. Civic Partners, particularly those that directly support delivery of The City's Economic Development and Tourism line of service, provide programs and services that contribute directly to the successful implementation of *Calgary in the New Economy: An economic strategy for Calgary*.

The development of a new Civic Partner Operating Grant Program, following the Terms of Reference approved by Council (CD2024-0752), to be implemented for the November 2025 budget adjustments process, will also support risk management throughout the cycle of partnering.
