BYLAW NUMBER 34P2015

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 28P95, THE CALGARY PLANNING COMMISSION BYLAW

WHEREAS Council has approved PUD2015-0453 and considers it necessary to amend Bylaw 28P95, as amended;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. The Calgary Planning Commission Bylaw, being Bylaw 28R95 of The City of Calgary, as amended, is hereby further amended.
- 2. Section 4 (b), (c), and (d) are deleted in their entirety and replaced with the following:
 - "(b) (i) Two members of Council/who shall:

(ii)

(iii)

- a. be appointed at the annual Organizational Meeting of Council,
- b. serve for a period of one year or until their successors are appointed, whichever occurs last,
- c. not be members of the Subdivision and Development Appeal Board of the City during their appointment, and
- d. In the temporary absence of a member of Council appointed pursuant to this section, such member of Council may, in writing, appoint an alternate appointed pursuant to subsection 4(b)(ii) below to act in his or her place.
- Two alternate members of Council, who shall:
 - a. serve as alternates for members of Council appointed under subsection 4(b)(i) in the event that member will be absent,
 - be appointed at the annual Organizational Meeting of Council, serve for a period of one year or until their successors are
 - appointed, whichever occurs last, and
 d. not be members of the Subdivision and Development Appeal Board of the City during their appointment.

A member of Council is not disqualified from appointment under subsection 4(b)(i) or (ii) by membership on the Commission while they hold the position of Deputy Mayor pursuant to subsection (4(a)(ii) above.

(c) (i) Eight citizens, who shall be appointed at the annual Organizational Meeting of Council and serve for a period of two years or until their successors are appointed, whichever occurs last.
