Re: Naming of Park in Saddle Ridge

I am pleased to provide this letter in support for the request forwarded by the Gobind Marg Charitable Trust Foundation to name the park in Savanna, Saddle Ridge as **Guru Tegh Bahadur Park**.

Sri Guru Tegh Bahadur was ordained as one of the 10 Gurus and holds a high stature and prominence in the Sikh faith due to his tremendous historic and religious contributions at the time in India. He is honored and remembered as the man who championed for religious rights freedom for all faiths.

The neighborhood of Saddle Ridge is home to thousands of Sikh faith followers. The Sikh community has, and continues to make, significant contributions to the culture, economy and social fabric of Ward 5 and Calgary as a whole.

The recent census for Ward 5 shows that 27% of residents speak Punjabi, the second highest spoken language after English.

This park is located at the doorsteps of the Gobind Sarvar School, a Sikh faith private school that serves over 1200 students from these neighborhoods from grades KG to Grade 12.

The naming of this park in recognition of the significant contributions by Sri Guru Tegh Bahadur will build a stronger sense of connection, heritage and belonging among users. Moreover, this would align with the Council's policy of equity, inclusion and diversity of communities present in Ward 5.
