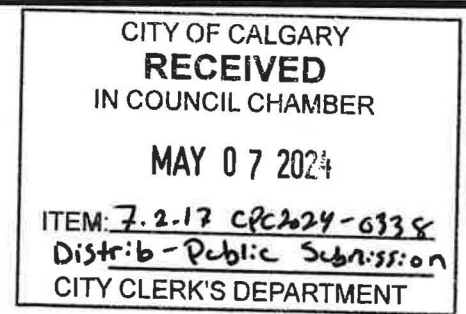

I'm hoping my comments can make it for the hearing tomorrow. I included the email thread for context.

These are my two comments:

My concern is the ARP for this area only allows a 4 storey project and this project is 6. Original ARP height restriction is 16 metres. This proposed project is 28 metres.

Also, the project has 57 apartments with only 39 allotted parking spaces.

I would like it confirmed the additional 18 apartments will Not be rented to tenants with a vehicle. (57 subtract 39). The city advises people have less vehicles than in reality, therefore the tenants renting must support the empirical data described for the parking allotted. Residents of Parkdale should not have to have our already restricted parking, which we have to pay for, taken away by the residents of this proposed project.
