That Council:

- 1. Adopt, by resolution, the proposed community name: Ambleridge; and
- 2. Adopt, by resolution, the proposed street names: Ambleridge, Amblestone.

#### **HIGHLIGHTS**

- This application proposes the new community name Ambleridge and new street names Ambleridge and Amblestone.
- Administration recommends approval of the proposal as it complies with the Municipal Naming, Sponsorship and Naming Rights Policy and aligns with the Community Plan Area identified in the Glacier Ridge Area Structure Plan (ASP).
- What does this mean to Calgarians? Municipal naming of communities plays an important role in defining communities and navigation within Calgary.
- Why does this matter? This proposal aligns with the ASP for Community C which provides one consistent name for the whole Community C area.
- The application is associated with LOC2023-0316, a land use amendment and outline plan application.
- There is no previous Council direction regarding this proposal.

# **DISCUSSION**

Stantec Consulting Ltd., on behalf of the landowner, Qualico Communities has submitted a new community name of Ambleridge on 2022 April 18. The proposed new community will be used in the area south of the 160 Avenue NW alignment, west of 24 Street NW, east of Symons Valley Road NW and north of 144 Avenue NW. It is identified as Community C in the ASP, the area shown in orange on Attachment 2 in this report.

The intent of the ASP policy was to establish four complete communities within the ASP. Section 3.1.1 of the ASP states "The Plan Area should create four Communities and 18 Neighbourhoods and one District as shown on Map 4: Communities and Neighbourhoods." This application will align with that vision by creating one community name for the entire Community C area and has the support of the three major developers/landowners.

The word "Amble" means to take a leisurely, pleasurable walk and has been chosen as the thematic element for the community to highlight the interconnected nature and mobility system
