Windsor Park is becoming more and more gentrified. I was one of the first houses that tore down a bungalow over 20 years ago. At first, my neighbours were really upset with me, tearing down the old property. But when they saw how hard I worked to ensure that we kept as many trees as possible, they became more forgiving.

My biggest concern is that the city is going to keep approving these mega condo structures and the builders will have no choice but to remove all established trees in order to complete the build of structures with such a massive footprint. Sure they'll add some fiddly little trees that won't have been researched for the way they are facing and be planted to close to the new structures all while the City of Calgary pockets that tree tear down financial penalty.

So... Either stop approving these massive structures. There's only so much urban density. We can continue with yet. You're still approving things on the outskirts of the city. Or force the builders to put in that are going to better populate the urban forest. Make the penalty for tear down of trees much stiffer. or be transparent in what you do to take those funds that you collect for taking down a mature tree in the city and put them in more public places. Our park has many opportunities for you to add new trees. And in the meantime, maybe take out the dead ones that didn't work.
