- feedback was primarily supportive
- some input on the desire to see activated frontage and a neighbourhood activity centre

- Discussion of NAC location / design, building orientation and street activation.
- General support for the vision, uses and densities/heights

Updated presentation to Springbank Hill Community Association

How did input influence decisions?

Building height

- The application aligns with the maximum building heights identified in the Springbank Hill Area Structure Plan
- The proposed concept represents building heights of up to 10 storeys, which is also consistent with adjacent and nearby mixed use multi-family development
- The applicant is proposing less than the allowable 10 storeys on a portion of the site

Site density

- The application is consistent with the density permitted in the Springbank Hill Area Structure Plan
- The submitted concept demonstrated how the proposed density could be developed across the site

Traffic

- An update memo for the existing Traffic Impact Assessment was prepared and no issues were raised based on this

Landscaping/open space

- Internal pathways and landscaping will be reviewed and confirmed through the development permit process, however where possible, existing tree stands will be preserved
- It is the intention to replant native species that thrive in the region as part of the landscape plan
- Detailed landscaping plans will be provided through future development permit application
