BYLAW NUMBER 36M2024

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 57M2016, THE VICTORIA PARK BUSINESS IMPROVEMENT AREA BYLAW *****

WHEREAS Council, by Bylaw Number 57M2016, continued the Victoria Park Business Improvement Area (the “BIA”), originally established by Bylaw 37M96;

AND WHEREAS section 8 of the *Business Improvement Area Regulation*, Alta. Reg. 93/2016 (“the Regulation”) provides a process for the amendment to the boundaries of a Business Improvement Area;

AND WHEREAS a request has been received to amend the boundaries of the Victoria Park Business Improvement Area;

AND WHEREAS notice has been sent to every taxable business within the existing BIA, and every business that would be taxable under the proposed change in boundaries, in accordance with sections 8(2) and 8(3) of the Regulation;

AND WHEREAS the Board of the BIA has consented to the change in boundaries, and the taxpayers within the BIA and the proposed new area have been provided with an opportunity to make representations to Council prior to second reading of this Bylaw in accordance with section 8(1) of the Regulation;

AND WHEREAS Council has considered C2024-0570 and deems it necessary to amend the Victoria Park Business Improvement Area Bylaw 57M2016;

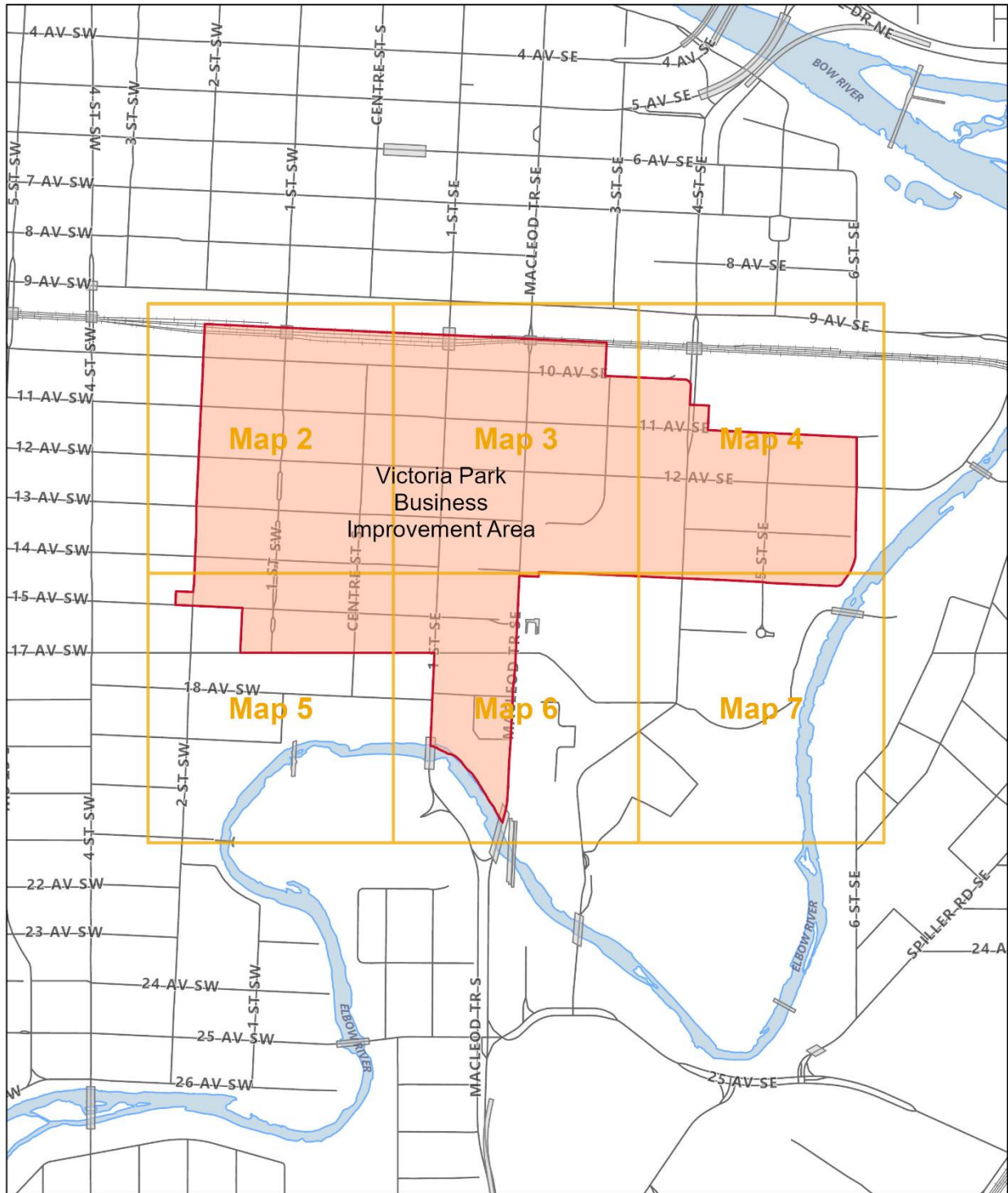
NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 57M2016, the Victoria Park Business Improvement Area Bylaw, is hereby amended.
2. The boundaries of the Victoria Park Business Improvement Area are amended by deleting Schedule “A” in its entirety and substituting the following in its place:

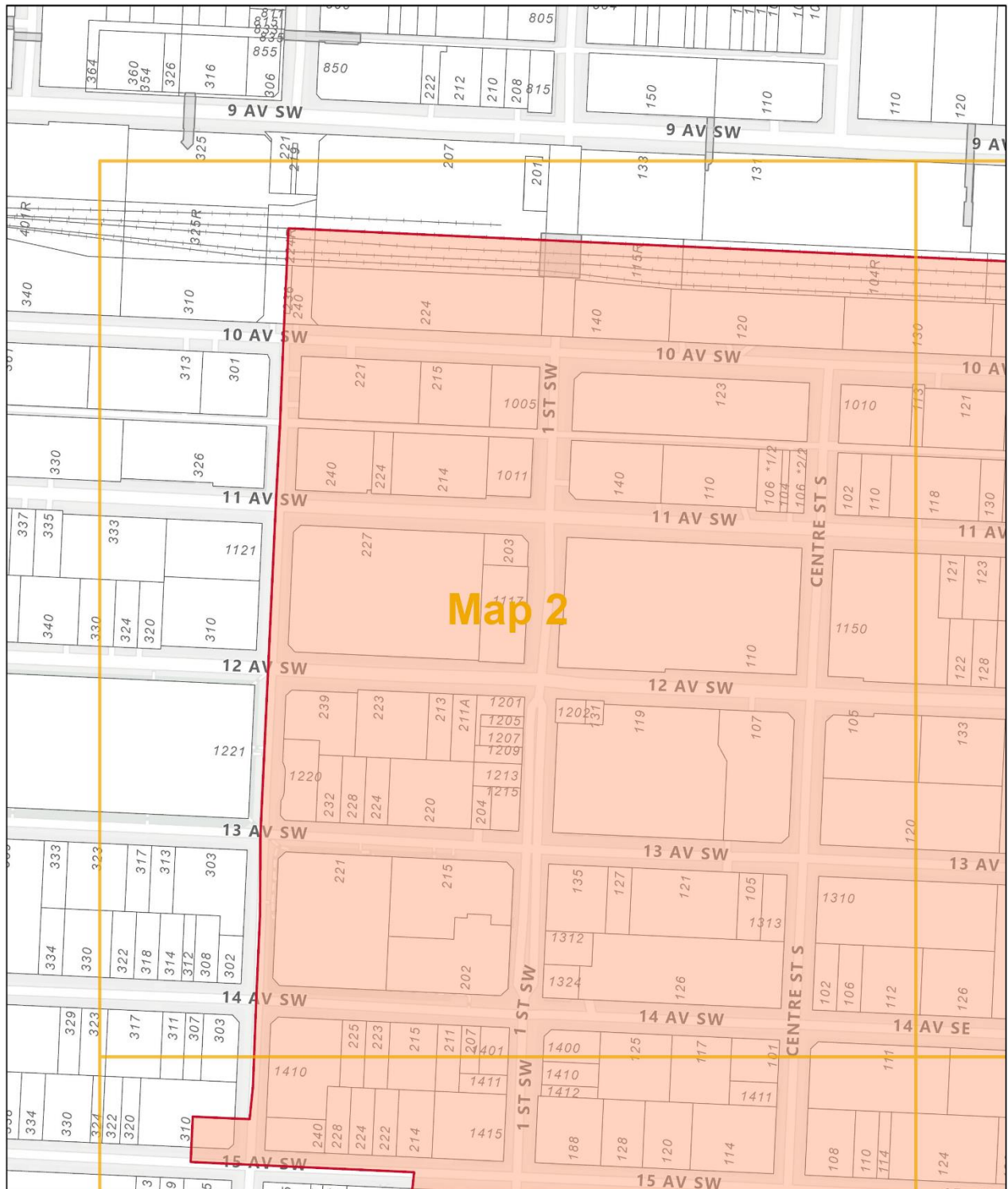
Map 1 - Overview

Map 2 - Detail

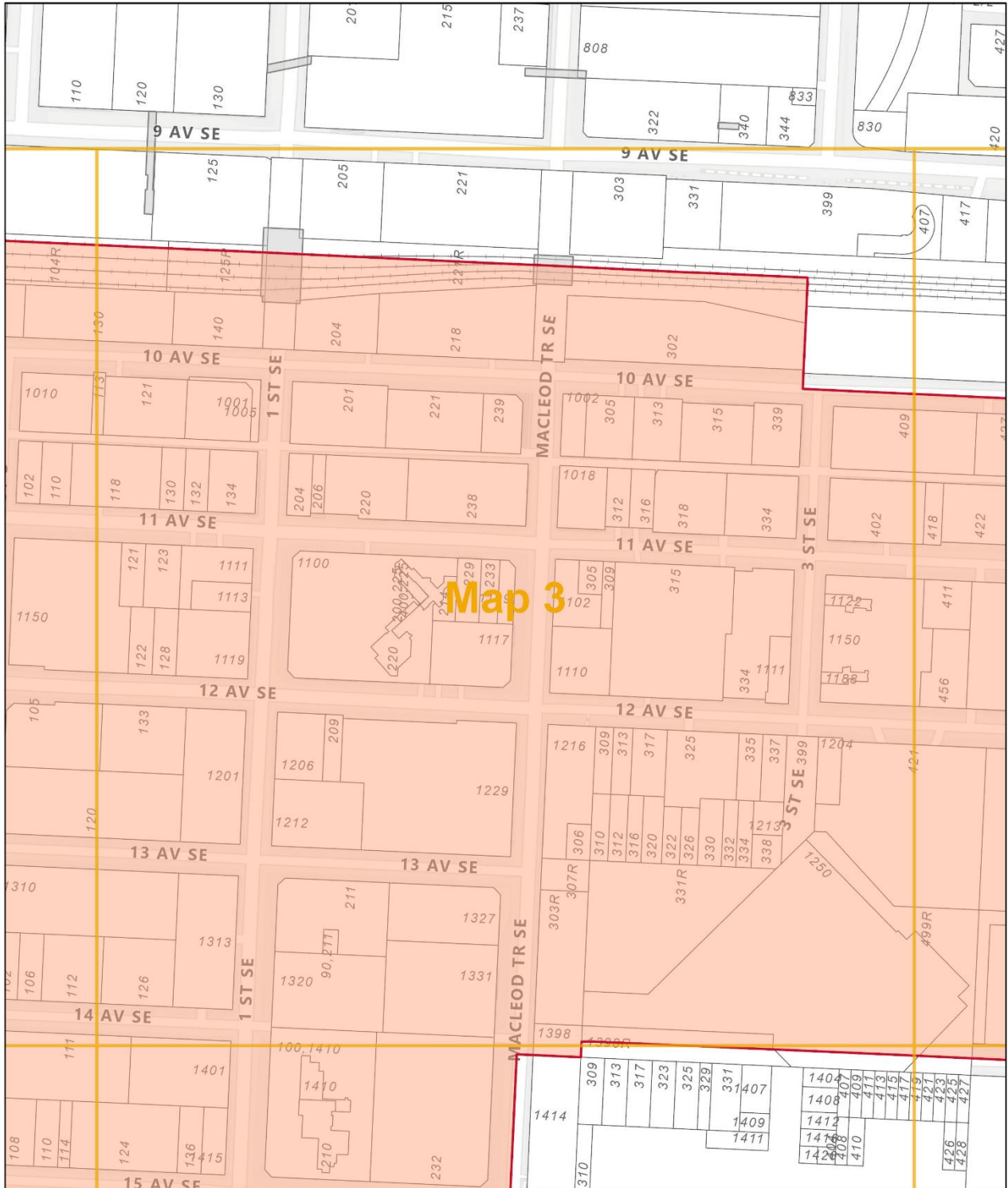

Map 3 - Detail

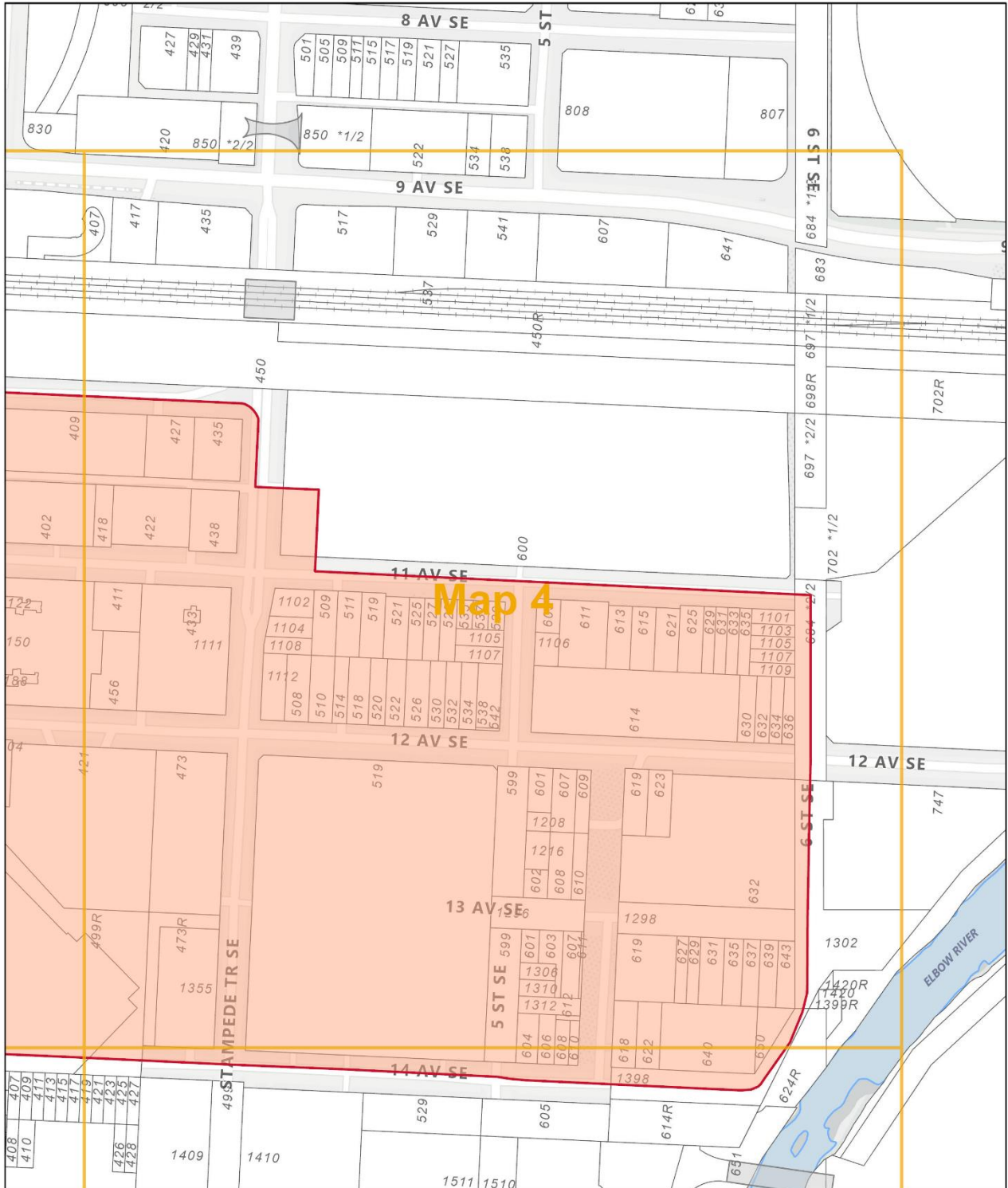

Map 4 - Detail

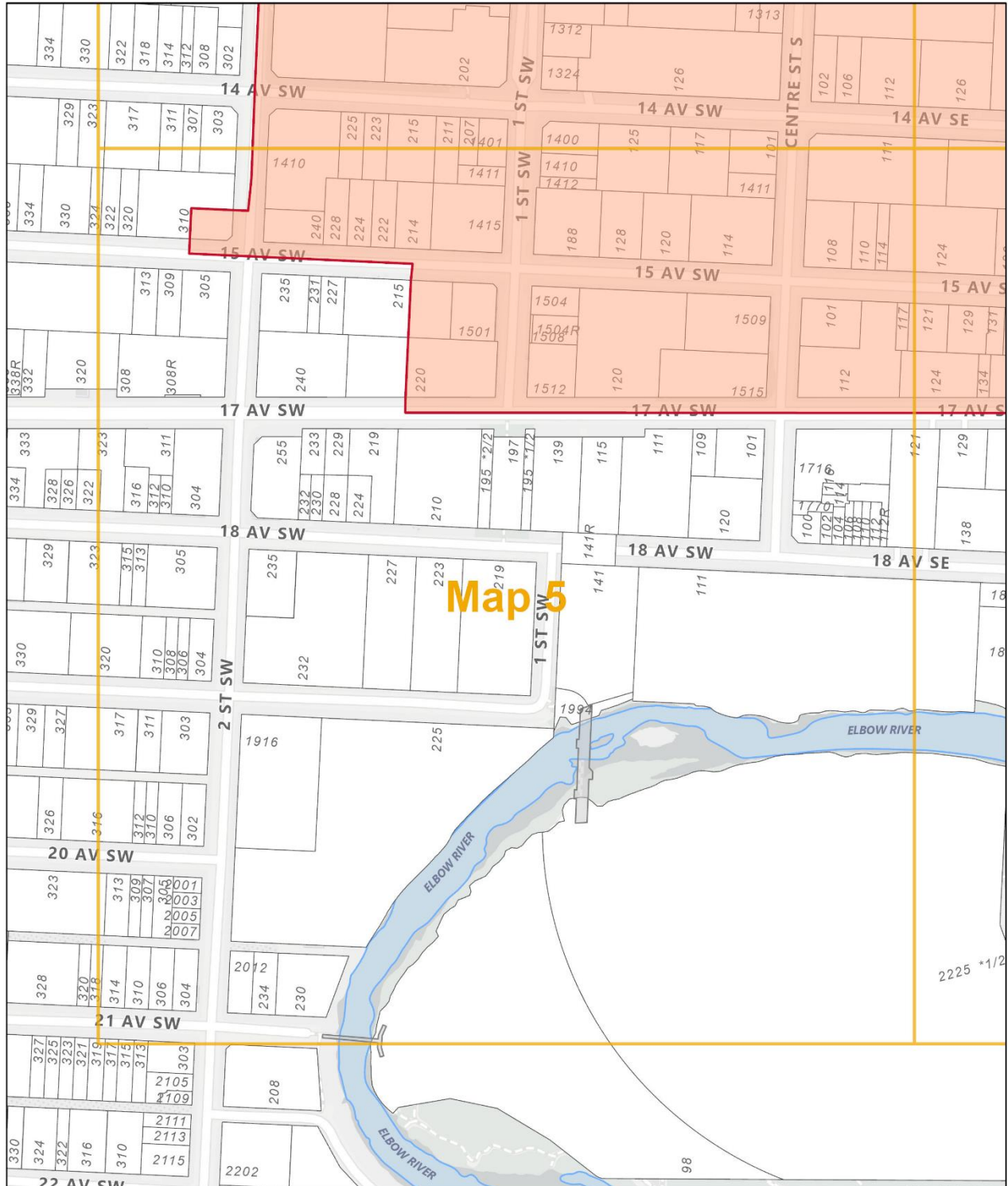

Map 5 - Detail

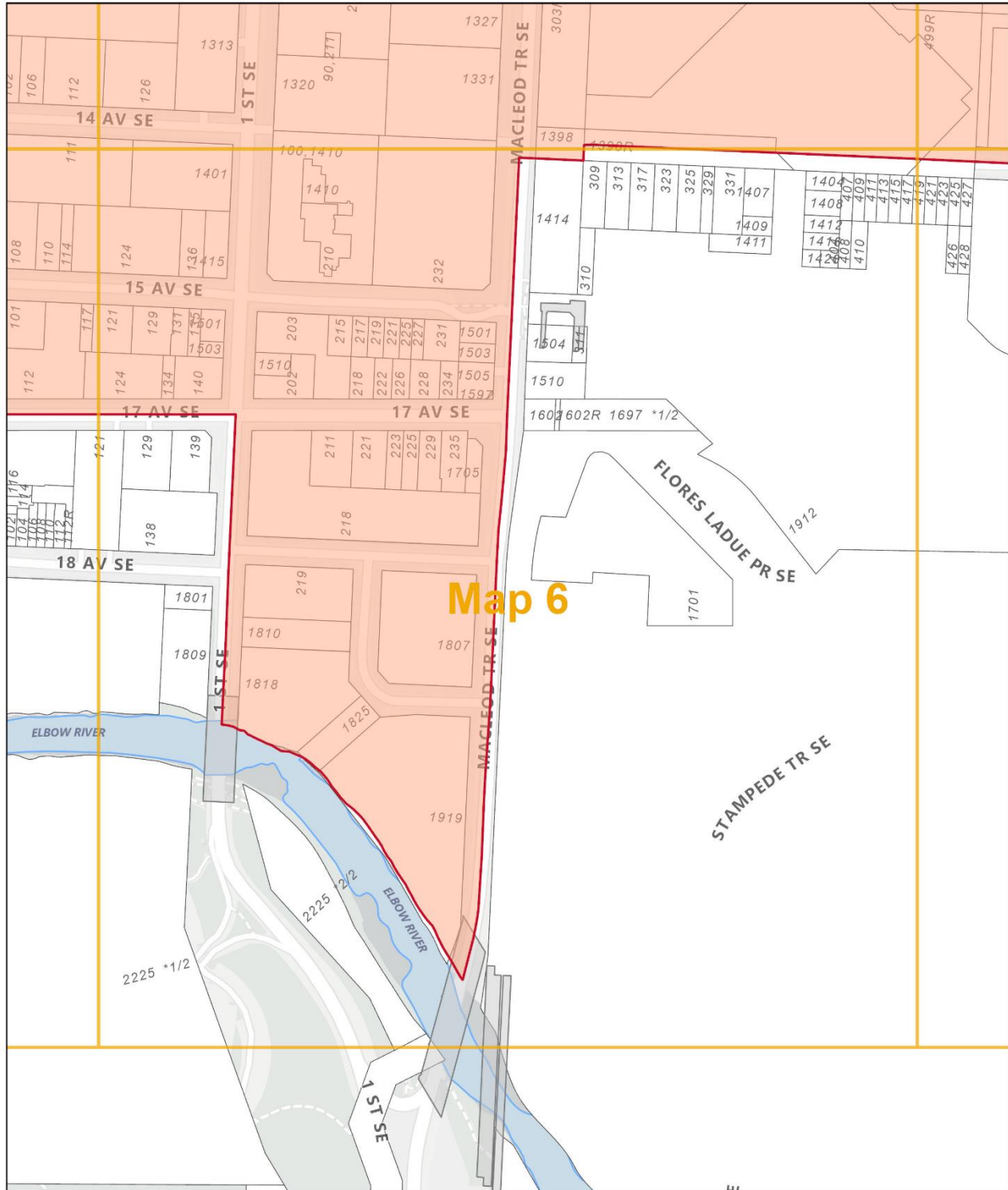

Map 6 - Detail

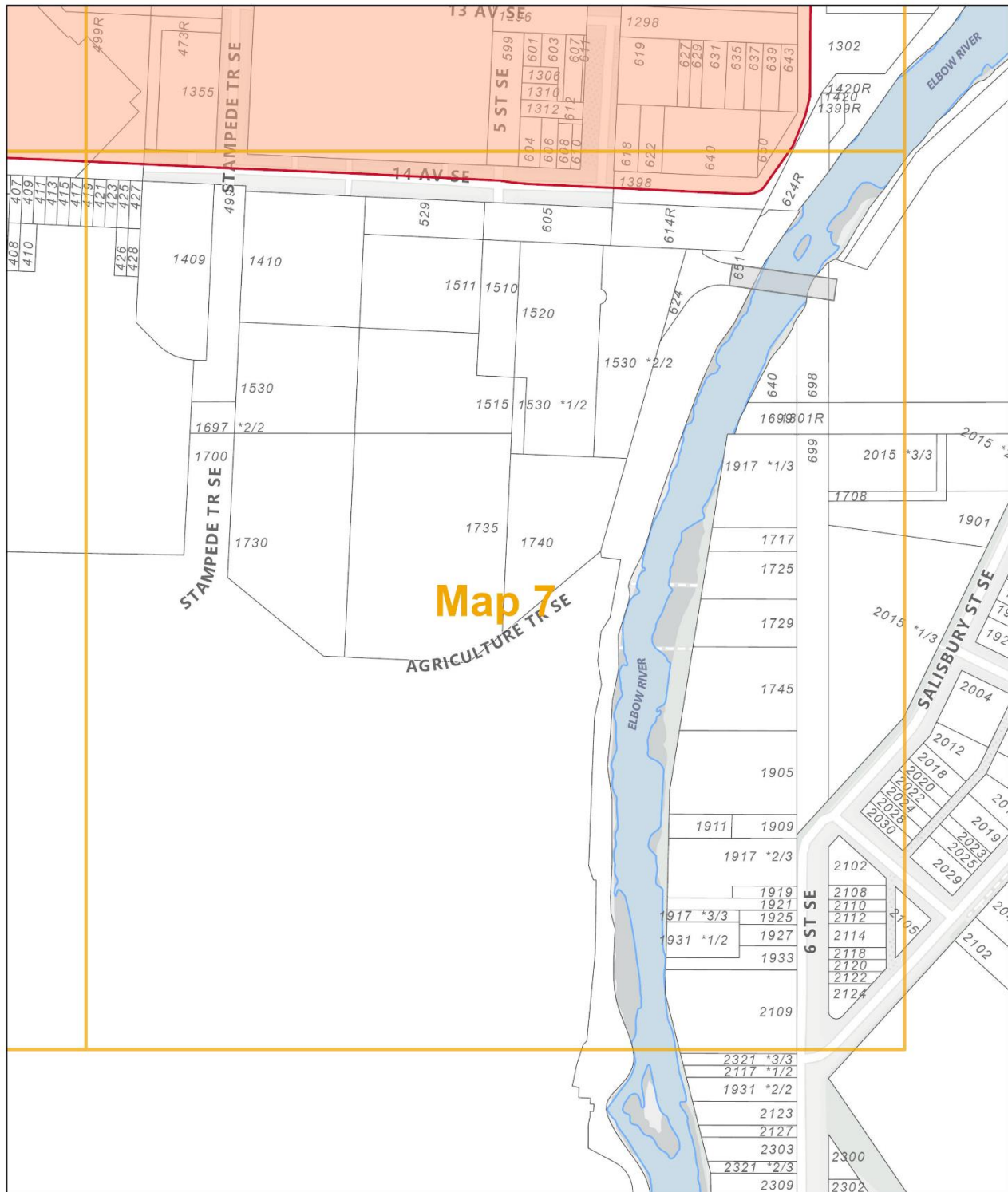
