Dear city council and related parties in the decision making of LOC2024-0097,

I am writing to voice my concern for the land redesignation of land located at 123 and 151 - 4 Street NE. I have reviewed the proposal and plan to redesignate the land for the installation of a Liquor Store within the building 300 metres away from another Liquor Store. I oppose the decision on the premise of security and safety of the tenants within building of which the proposed liquor store will reside. The building in question located on 123 - 4 Street NE has been subject to major security breaches since it's occupancy in 2023 involving break-ins and theft of tenant's bicycles and assets in storage units in Parkade 1 to Parkade 3 in the building. The building and it's tenants continues to battle mail theft from unwanted visitors whom gained unauthorized access and the residents remain concerned for their own safety. Including the access of unwanted visitors on the building premises the introduction of a liquor store inset on the premises will only worsen the safety of the tenants in the building and increase crime in the area. Furthermore the building is located 300m away from Bridgeland Liquor Store at 630 1 Ave NE, Calgary, AB T2E adjacent to the PetroCanada Gas Station which the owners of said establishment have been battling crime, unwanted visitors, theft and violence in the area over the years and the entire strip mall remains very active in police activity. I sincerely and firmly oppose the decision to redesignate the land given the evidence of increased crime in the area for the outright number of police calls to the area and for the safety of the tenants including my own.
