## BYLAW NUMBER 34M2024

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 32M2023 THE COMMUNITY STANDARDS BYLAW \*\*\*\*\*

**WHEREAS** Council has considered report CD2024-0841 and deems it necessary to amend Bylaw 32M2023, the Community Standards Bylaw;

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. Bylaw 32M2023, the Community Standards Bylaw as amended, is hereby further amended.
2. In section 1(2), after subsection 1(2)(m), the following is added as subsection 1(2)(m.1):  
“(m.1) *“Event Centre”* means the area in The City of Calgary bounded on the west by Stampede Trail, on the south by 14<sup>th</sup> avenue SE, on the east by the street running north-south located between Stampede Trail and 6<sup>th</sup> Street SE, and on the north by 12<sup>th</sup> avenue SE;”.
3. Section 24(2) is deleted, and the following is substituted:  
“(2) Notwithstanding subsection (1) and section 33(1)(g), where the *Ambient Sound Level* for an area is at or above the maximum allowable *Sound Level* limits referred to in either subsection (1) above or section 33(1)(g), measured over a 15-minute period, a *Sound Level* must exceed 5 decibels (dBA) *Leq* over the *Ambient Sound Level* before it becomes an offence.”.
4. In section 33:
  - (a) In subsection 33(1)(e), the word “or” is deleted.
  - (b) In subsection 33(1)(f), after the words “Province of”, the words “Alberta;” are deleted and the following words are substituted:  
“Alberta; or”.
  - (c) After subsection 33(1)(f), the following is added as subsection 33(1)(g):  
“(g) activities held inside the *Event Centre* where the *Sound Level* does not exceed 64 decibels (dBA) *Leq* at any *Point of Reception* within a *Residential Development* between the hours of 10:00 p.m. and 11:59 p.m.”.
