

Notice of Motion Checklist

The checklist is a tool intended to support the sponsor(s) of a Notice of Motion. The items listed below are important considerations when crafting and submitting a Notice of Motion. It is also intended to support other Members of Council, as the same considerations are important when reaching a decision on a Notice of Motion.

The checklist is therefore an opportunity for the sponsor(s) to:

- Consider what advice might be helpful to them in formulating their proposal; and
- Share key points about the advice received with their council colleagues, to inform their deliberations.

This document is recommended to be provided to City Clerks alongside every Notice of Motion and will become part of the Corporate record. It is at the discretion of the sponsor(s) to decide with whom to consult and what information to include.

Title of the Motion: **Assessing the “Efficiency and Financing Requirements of the Police Service:” Community Safety Investment Framework & The Calgary Police Service’s Proposed Shooting Range**

Financial and Other Resource Capacity
No Financial and/or other resource capacity challenges. This falls within the standard budget process, and utilizes/requests reports that are already existing. Minimal administrative work is required to prepare what is asked below.
Legal/Legislative
Legal was circulated, and specific language was crafted to ensure that the proposed resolutions fall within the mandate that the Police Act provides for City Council. This NoM requests information to assess the efficiency and financing requirements of the police service. There is no operational ask, nor is there direction to CPS or Commission. The resolutions were crafted to align with the Police Act.

<p>Procedural (Include reasons for confidentiality)</p> <p>This requires an urgent NoM due to the timing of the budget submissions, the national wave of Indigenous deaths in police custody or during interactions with police, and the requirement to finalize budget submissions in advance of November.</p>
<p>Other Considerations</p> <p>Significant crossover is present in the purpose of this NoM and past Council and Commission commitments and strategies: Mental Health and Addiction Strategy, Family Community and Social Services, and the Anti-Racism Strategy.</p> <p>The City of Calgary and the Calgary Police Service committed to more than just organizational reform in their commitment to anti-racism, they committed to supporting community to heal the legacies of anti-racism and colonization.</p> <p>Due to the sensitive nature of recent events involving the deaths of Indigenous people in Police Custody or during an interaction with Police, as well as the realities of Truth and Reconciliation Day occurring mere days prior to the proposed Executive meeting, this NoM was circulated and feedback was incorporated from CAUAC, the Anti-Racism Team, Community Strategies, Law, and with support from community members.</p> <p>It is important to note that no culture or people are a monolith, so while feedback was sought, it is with humility I remind people that no feedback loop could ever incorporate the breadth of knowledge available to support this work.</p>
<p>Urgency Rationale</p>

This requires an urgent NoM due to the timing of the budget submissions, the national wave of Indigenous deaths in police custody or during interactions with police, and the requirement to finalize budget submissions in advance of November.
