Subject: Submission in Response to Land Designation Change Proposal for 2306-16A St SW, Calgary, AB

To Whom It May Concern,

I am writing to submit my response to the proposal for a change in land designation to allow for higher-density development at the property located at 2306-16A St SW, Calgary, AB. I understand that the proposed change aims to rezone the area for more intensive residential development, and I would like to voice my concerns regarding this proposal.

While I recognize the need for urban growth and increased housing in Calgary, I believe that this particular area may not be suitable for the proposed high-density development from 72 units to 111 units for the following reasons:

- 1. Impact on Traffic and Parking: The current infrastructure in this area may not be equipped to handle the increased number of vehicles and residents that come with higher-density developments. Increased traffic congestion could lead to safety concerns and a diminished quality of life for both current residents and future ones. Just this past weekend with the snow was evidence of the tight streets and vehicles sliding down the hills hitting vehicles on both sides of the street. The roads are rarely cleared of snow and specifically on this hill. There is currently no parking designation on the east side of 17B ST due to it being so narrow which this development would be built against.
- 2. **Neighborhood Character and Aesthetic**: The current low-height multifamily zoning is in line with the residential character of the neighborhood. The introduction of high-rise buildings could significantly alter the look and feel of the area, potentially reducing the appeal of the community for long-term residents. Additionally, we enjoy views from our homes to single family homes and the change to high-density would cause a severe lack of privacy and security in our homes.
- 3. **Pressure on Public Services**: Higher-density developments often strain local public services such as schools, healthcare facilities, and recreational spaces. This proposed change could result in an unsustainable demand for services that may not be able to meet the increased population.

I would like to request that further consultations be held with the local community, as many residents, including myself, may have valuable feedback to provide on how this project could better align with the existing neighborhood. I strongly encourage the city planners to consider alternative approaches that strike a balance between growth and the preservation of the unique character of the area.
