Introduction

A user fee is a payment charged in exchange for a good or service provided by The City. User fees are paid directly by those who benefit from a service and are an important part of diversified municipal revenues, which help reduce reliance on property taxes and other revenue sources used to provide City services. All proposed user fees are set in accordance with the User Fee Policy (CP2024-02), which considers the full costs of providing the good or service, market demand and the extent of public versus individual benefit derived.

The annual adjustments process allows for changes and updates to fees and rates. The Council approval process for user fees involves:

1. Council approval of target long-term tax support rates (*completed 2018 May*)

This is the percentage of each service's full costs that are expected to be recovered through user fees. The long-term tax support rates approved by Council in report C2018-0586 on 2018 May 16 were used for setting user fees and rates for 2023-2026.

2. Council approval of detailed fees for 2023-2026 (*completed 2022 November*)

Council approved the specific rates and fees for each service for their four-year service plans and budgets (C2022-1051).

3. Council approval of adjustments to fees

Currently approved fees for the 2023-2026 Service Plans Budgets include the original approvals in 2022 November and subsequent adjustments in 2023 November (C2023-1148). Where fees are proposed to change from what is currently approved, they are reflected in this attachment:

- Adjustments to fees set by Council resolution will be approved by resolution.
- Adjustments to fees contained in bylaws will be approved by Council giving three readings to the amending bylaws.

Summary

Table 1 shows fees increasing from the approved 2023-2026 fees. Table 2 summarizes fees decreasing from the approved 2023-2026 fees. Table 3 summarizes new fees and fee structures. Table 4 outlines clerical updates to Council-approved fee schedules. Table 5 is presented for information and summarizes changes that do not require Council approval through this process.

**BEING A BYLAW OF THE CITY OF CALGARY
TO AMEND BYLAW 40M2006, THE WATER
UTILITY BYLAW**

WHEREAS Council has considered C2024-1097 and has decided to amend the 2025 and 2026 fees contained in the Water Utility Bylaw 40M2006.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 40M2006, the Water Utility Bylaw, as amended, is hereby further amended.
2. Schedule “A” is deleted in its entirety and the following is substituted:

“SCHEDULE "A" - WATER RATES

The rates or charges described in this Schedule are shown for the years 2023, 2024, 2025 and 2026, and shall apply in the calendar year indicated (from January 1 to December 31, inclusive).

Monthly rates or charges described in this Schedule are based on a thirty (30) day period. The amount billed shall be established by dividing the applicable monthly rate or charge by thirty (30) to derive a daily rate and multiplying the daily rate by the actual number of days in the billing period.

- b) Where the estimated cost of constructing the approved building or alteration or repair thereof exceeds Twenty-Five Thousand Dollars (\$25,000.00), the Director, Community Planning may require that a water meter be installed, and the applicant will pay for the installation and removal of the water meter and for the water supplied at the General Service Metered Water Rate as set out in Table 1 and Table 2 of Schedule "A" to this Bylaw.

TABLE 7 - WATER DISPENSED THROUGH HYDRANTS WITH A HCU UNIT

As a condition of renting a Hydrant Connection Unit, the hydrant user is responsible to pay to the City a monthly service charge equivalent to the monthly service charge for the Bulk Water Stations as set out in Table 5 of Schedule "A" to this Bylaw plus a consumption charge equivalent to the Bulk Water Rate as set out in Table 2 of Schedule "A" to this Bylaw."

BYLAW NUMBER 40M2024

**BEING A BYLAW OF THE CITY OF CALGARY
TO AMEND BYLAW 14M2012, THE
WASTEWATER BYLAW**

WHEREAS Council has considered C2024-1097 and deems it necessary to amend the 2025 and 2026 fees contained in the Wastewater Bylaw 14M2012;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 14M2012, the Wastewater Bylaw, as amended, is hereby further amended.
2. Schedule “D” is deleted and the following is substituted:

“SCHEDULE “D”

MONTHLY WASTEWATER CHARGE

The rates or charges described in this Schedule are shown for the years 2023, 2024, 2025, and 2026, and must apply in the calendar year indicated (from January 1 to December 31, inclusive).

Monthly rates or charges described in this Schedule are based on a thirty (30) day period. The amount billed must be established by dividing the applicable monthly rate or charge by thirty (30) to derive a daily rate and multiplying the daily rate by the actual number of days in the billing period.

1. For residential flat rate customers served with water from *The City’s* water supply, the *wastewater* charge is calculated as a percentage of the water charge according to the following:

The customer must pay a fee of \$25.00 for each access card (fee refundable on return of card), in addition to payment of a service charge and volume charge, as described below.
