#### **Executive Summary**

During the Regular Meeting of Council on October 30, 2024, three Notices of Motion with direct implications on the Mid-Cycle Adjustments were approved:

- Strengthening Transparency: Improving Engagement with Calgarians (EC2024-1130),
- Historical Resource Property Tax Cancellation and Subclass (EC2024-1116), and
- HMCS Calgary 30th Anniversary and Ongoing Calgary Salutes Support (EC2024-1117).

Below, you will find a one-page investment outline detailing the budget requests for each approved Notice of Motion. These are presented for Council's consideration to be included in the Mid-Cycle Adjustments as potential investments. Currently, these initiatives do not have an identified funding source. In order for any of the items listed here to be included in the approved adjustments, a motion to amend Administration's recommendations will be required.

#### Strengthening Transparency: Improving Engagement with Calgarians

#### **Investment Description**

At the October 29 Regular Meeting of Council, Councilor Wong brought forward Notice of Motion - Strengthening Transparency: Improving Engagement with Calgarians, EC2024-1130 which directs Administration to contact an independent, third-party consultant accredited in public participation to:

- Conduct an analysis of The City's policy and approach to public participation and engagement through feedback and validation in contrast to industry best practices in public participation and engagement (e.g. IAP2)
- Identify lessons learned and develop opportunities to improve public participation and engagement with Calgarians.

This work is currently unfunded and not resourced, therefore this request is bring brought forward as part of Mid-Cycle Adjustments to the 2023-2026 Service Plans and Budgets for Council's consideration to fund this work.

NOTE: this is a high-level estimate at this time and the procurement process is underway. An updated budget estimate will be provided when available.

## **Designated Historical Resource Property Tax Cancellation and Subclass**

#### **Investment Description**

This investment is required to implement Council's direction, received through Notice of Motion EC2024-1116, to incentivize municipal historic resource designations through property tax cancellations equivalent to 15 per cent of the municipal property tax levy. A base operating budget of \$600,000 in 2025 and an additional \$100,000 in 2026 is required to fund the tax cancellation amounts for currently designated municipal historic resources, cover an expected 20 new designations per year and administer the incentive.

#### **Benefits**

ISC: UNRESTRICTED

This investment will motivate landowners to legally protect their historically important properties. Protection of Calgary's heritage resources through designation is an essential part of conserving our history, culture, and identity. A 2020 Citizen Perspective Survey indicates a majority of Calgarians agree that conservation of Calgary's historic buildings and sites is important to them personally (83%), to Calgary's culture (94%) and for future generations to enjoy (86%).

#### Risk of not proceeding with investment

There is a risk that buildings that are important to the history of Calgary will be lost because opportunities to redevelop their sites outweigh the financial benefits of preserving the building. By providing a financial incentive in the form or a tax cancellation, the landowner may be motivated to protect the building rather than choose redevelopment.

#### Risks of proceeding with investment

ISC: UNRESTRICTED

This investment may motivate more landowners than anticipated to designate their properties in order to receive the tax cancellation. Meeting this demand may require more funding in the future. The funds required to cancel the taxes to these properties will not be available for other service investments.

#### **HMCS Calgary 30th Anniversary and Ongoing Calgary Salutes Support**

#### **Investment Description**

As a result of a Notice of Motion (NoM), Council directed Administration to return to Council with a recommended yearly budget for the Calgary Salutes Committee to assist in the planning and execution of events and programs on an ongoing basis. The NoM also directed one-time funding of \$50,000 be directed to the Committee to plan and execute the 30<sup>th</sup> anniversary of the HMCS Calgary, and one time funding of \$15,000 to the Office of the Councillors to support travel to the above event.

The one-time funding will be managed through internal transfers from both Community Partners and Council Services for 2025.

#### **Benefits**

The one-time funding will support the celebrations related to the 30<sup>th</sup> anniversary of the HMCS Calgary. Benefits will be in the number of elected officials who attend, the attendees to the celebration, and any fundraising associated with the event (donated to charities). The proposed on-going funding, subject to Council approval as part of budget adjustments, would similarly support the work of the committee and would be measured in number of events supported, fundraising, and potentially surveys of the effectiveness of the committee.
