Previous Council Direction, Background

Background

On 2021 March 1, Council directed Administration through Notice of Motion PFC2021-0222 to address the negative impacts of waste and recycling sites by establishing and hiring a new Waste Officer position and forming an inter-departmental working group.

On 2021 July 5, Council approved a new one-time operating budget request of \$300,000 to fund an internal Officer for a 24-month period (UCS2021-0903) and directed Administration to report back no later than 2022 Q3 through the appropriate Standing Policy Committee to fulfill the remaining actions.

On 2022, July 26, through C2022-0896, Council approved amendments to the Land Use Bylaw 1P2007 to enable better regulations for Waste Management and Storage Uses.

On 2022 September 9, through IPC2022-0906, Administration requested a deferral of the report back on Minimizing Negative Impacts of Waste and Recycling Sites to no later than 2023 Q2 to align with proposed amendments to the Business License Bylaw that will further advance progress on mitigating negative impacts of waste and recycling sites.

On 2023 July 4, through IP2023-0501, Council directed Administration to bring amendments to the Business Licence Bylaw 32M98 to address concerns around public health, safety and environmental impacts from the operations of waste and recycling sites in Calgary by no later than 2024 Q2.

On 2024 June 26, through CD2024-0768, Administration requested a deferral of the report back on amendments to the Business License Bylaw 32M98 to no later than 2024 Q4.
