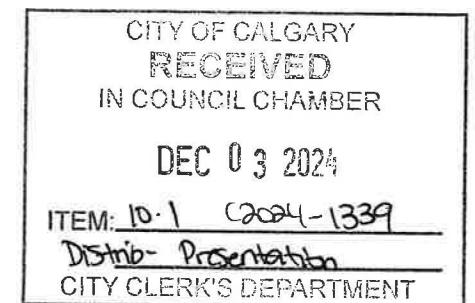

That with respect to Verbal Report C2024-1339, the following be adopted:

That Council, for the remainder of the current term of Council:

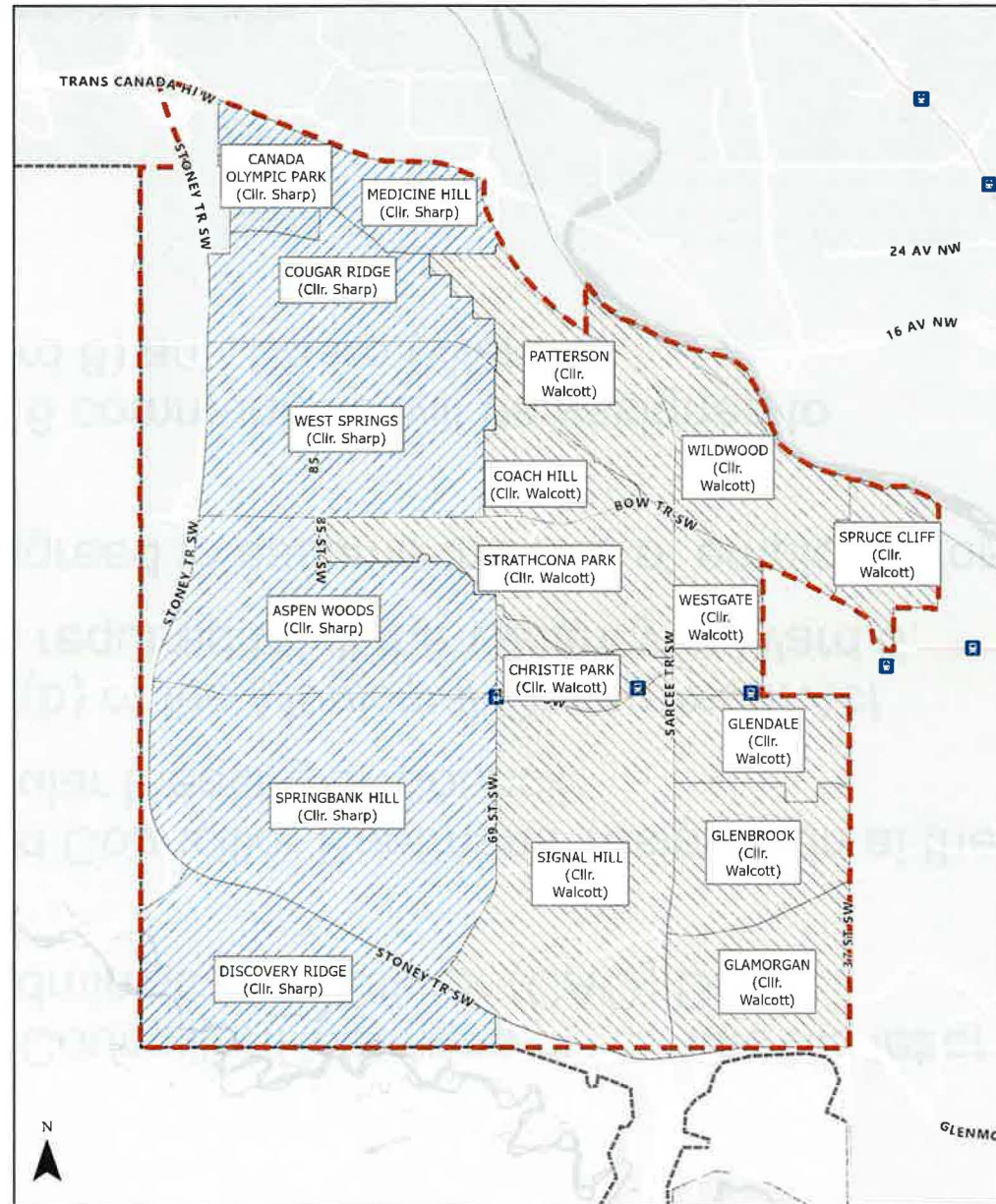
1. Effective 2024 November 27, direct that Councillor Walcott (Ward 8) be approved as the employing Councillor of Ward 6 Assistants;
2. Assign representation for Ward 6 communities as follows:
 - a. Councillor Sharp (Ward 1): Medicine Hill, Canada Olympic Park, Cougar Ridge, West Springs, Aspen Woods, Springbank Hill and Discovery Ridge
 - b. Councillor Walcott (Ward 8): Patterson, Wildwood, Coach Hill, Spruce Cliff, Strathcona Park, Westgate, Christie Park, Signal Hill, Glendale, Glenbrook and Glamorgan
 - c. Councillor Penner (Ward 11) will be the primary Council liaison for constituent matters pertaining to Tsuut'ina Nation.
3. For the purposes of Section 10(m) of the *Councillors' Budgets and Expenses Bylaw 36M2021*, authorize Councillor Walcott and Councillor Sharp to make decisions about applications made under the Ward Community Event Fund for events or initiatives to be held in Ward 6 communities as set out in Recommendation 3, within the allocated amount of the Ward Community Event Fund set for Ward 6.



Highlights

- On 2024 November 26, Councillor Pootmans presented his letter of resignation to Chief Administrative Officer (CAO) David Duckworth.
- CAO Duckworth reported Councillor Pootmans' resignation at the 2024 November 26 Regular Meeting of Council.
- Pursuant to Section 162(b) of the *Municipal Government Act* (MGA), no by-election is required to fill the vacancy in Ward 6.
- Councillor Walcott has agreed to assume the role of employer for existing Ward 6 Staff.
- Representation of Ward 6 communities will be assigned to Councillors Walcott (Ward 8) and Sharp (Ward 1).
