## Recommendations

## Background



At the November 26th Regular meeting of Council, Chief Administrative Officer Duckworth announced that he had received a letter of resignation from Councillor Pootmans.

Pursuant to section 161(3) of the *Municipal Government Act*, "the resignation is effective on the date it is received by the chief administrative officer even if a later date is set out in the resignation."



# Council Policy – Governance and Appointments of Boards, Commissions and Committees (CP2016-03)

## Section 5.6.2(b):

"the appointment term for Council Members shall: b) Terminate immediately upon leaving office."

#### **Section 5.6.4:**

"in the case of a mid-term Council Member vacancy, the City Clerk's Office will canvass all Councillors for interest in the applicable BCC and bring a report forward for Council to make an appointment."

  - \*\* Then Councillor Pootmans was appointed to represent the Rocky View County and City of Calgary Intermunicipal Committee, which Councillor Chabot also represents. Any other Councillor can therefore be appointed to IGA.
