I am a breeder of Labrador Retrievers. Although I am not in the city, I can't support blanket bans on the sale of all pets.

Bans on pet stores and controls to regulate breeding? Yes. But blanket bans like this throw the baby out with the bathwater.

While there are no doubt poor quality breeders in the city, there are also no doubt no shortage of wonderful breeders in the city.

Purposefully bred healthy dogs should be available to families who want them.

There needs to be a lot more oversight of this industry, but I don't believe decisions at the municipal level will have any significant effect. It will simply drive both responsible and irresponsible breeders outside the city limits. And while I would be happy to see irresponsible breeders inconvenienced, I would be sad to see responsible breeders experience the same.

Although likely not a municipal issue, I would suggest to animal rescue organizations focus on banning the importation of rescue pets from other counties. Those animals need to be sterilized/homed where they are, as the supply is indeed endless. The onset on international rescuing brings disease and reduces the number of families who may otherwise provide homes for your pets.

Comprehensive Argument: Why Animal Breeding is Problematic and Rescue Organizations Offer Better Solutions

1. Overpopulation Crisis

- The Problem of Overpopulation: Millions of animals are euthanized in shelters annually due to a lack of homes. Breeding animals contributes to this crisis by introducing more animals into an already oversaturated system.
- Shelters as a Solution: Rescue organizations like The Calgary Humane Society work to rehome abandoned and unwanted animals, helping to reduce the strain on resources and prevent euthanasia.

2. Ethical Concerns

- Exploitation in Breeding: Animal breeding often prioritizes profit over the well-being of the animals. Breeding facilities, particularly puppy and kitten mills, keep animals in inhumane conditions, forcing them to reproduce repeatedly.
- Rescue Organizations: In contrast, shelters prioritize animal welfare, offering medical care, proper nutrition, and a safe environment for animals who have often been neglected or abused.

3. Health Issues in Bred Animals

- Genetic Problems: Many bred animals suffer from health problems due to inbreeding or selecting for specific traits (e.g., hip dysplasia in German Shepherds, respiratory issues in flat-faced breeds like pugs). These issues compromise the animals' quality of life and lead to costly veterinary care.
- Adopted Animals: Rescued animals come from diverse genetic backgrounds, often resulting in fewer hereditary health issues. Shelters also provide medical screenings and vaccinations before adoption.

4. Adoption Reduces Demand for Breeding

- **Supply and Demand**: Every adoption decreases demand for bred animals, discouraging breeders from continuing harmful practices. By adopting from rescue organizations, individuals send a clear message that they support ethical and sustainable pet care.
- **Proactive Outreach**: Organizations like The Calgary Humane Society also educate the public about responsible pet ownership and the consequences of animal breeding.

5. Societal and Cultural Shifts

- Companionship Without Exploitation: Breeding perpetuates the idea of animals as commodities. Rescue organizations, however, foster a culture of compassion, viewing animals as sentient beings deserving of care and respect.
- Engaging the Community: Groups like The Calgary Humane Society actively involve communities in rescue and rehabilitation efforts, creating a ripple effect of awareness and empathy.

6. Supporting Spay and Neuter Programs

- Breeding vs. Population Control: Breeding directly opposes the goals of spay and neuter initiatives aimed at controlling stray populations. Rescue organizations often run or support such programs to prevent further overpopulation.
- Accessible Services: Shelters frequently offer affordable spay and neuter services, ensuring that even low-income families can contribute to reducing stray populations.

Conclusion

Animal breeding perpetuates overpopulation, and exploitation, while rescue organizations like The Calgary Humane Society provide ethical and sustainable solutions. By choosing adoption, individuals support a compassionate system that prioritizes animal welfare, reduces, and contributes to a cultural shift towards more responsible pet ownership.

I wholeheartedly support the limiting of the sale of companion animals and of measures that will improve responsible pet ownership. My particular interest in rabbits, but my comments apply to other pets as well. The crisis of rabbit abandonment is directly related to the irresponsible sale of them on places like Kijiji. I believe that all animals sold or adopted as companion animals should be required to have proof of surgical alteration. This will go a long way to solving the never ending problem of callous, uncaring people selling cute baby bunnies knowing that they are not easily sexed when they are babies and will become capable of breeding within a matter of a few months. This perpetuates the challenge posed to all rescues of having to rescue abandoned female bunnies that are almost certainly pregnant, and then being forced to choose between spaying the rabbit and knowingly killing innocent babies, or allowing the babies to be born and thus adding to the cost of rescue and the difficulty of finding good homes for the whole family of rabbits. Enough is truly enough! We need to address the root cause of the problem. Now is the perfect time for this as, sadly RHDV killed many of Calgary's feral rabbit population. As I imagine you are aware, rabbits are very able breeders and, if we allow the continued unchecked sale of rabbits, the feral populations will quickly reach the levels seen before. Feral rabbits pose a serious challenge for the communities in which they live too, eating residents' flowers and vegetables, sometimes causing property damage, and potentially luring predatory animals into communities. Putting an end to the rampant sale of the bunnies will help end the problem. The alternative will otherwise eventually be that the City may be forced to pursue more costly and, quite frankly, disgraceful measures like Canmore elected to pursue a few years ago. I will add a note that, as far as I know, Canmore was not successful in their feral rabbit population mitigation measures either. Calgary has the opportunity to have much better results at a much lower cost by simply banning the sale or adoption of unaltered pets. Thank you!


