As a dedicated, ethical breeder and member of the Canadian Kennel Club for over 30 years (lifetime member), I am deeply concerned by this motion. The wording of this motion is concerning and needs clarification. I do support banning the sale of dogs and cats in pet stores, however, I do not agree with the belief that dogs, cats and rabbits can only be sourced from local shelters or rescue organizations. I have consistently worked to improve my breed through rigorous genetic testing and adherence to strict breeding standards. My commitment to responsible breeding extends beyond the initial sale. I meticulously temperament test each puppy to ensure the best match for individual families. I maintain ongoing relationships with puppy owners, providing support and guidance throughout the dogs life and will take a puppy or dog back for any reason. By tracing lineage back to founding bloodlines, I can confidently predict the health and temperament of future generations. This level of knowledge and expertise is usually absent in less regulated breeding practices and not associated with animals from local shelters or rescue organizations. By discriminating against ethical breeders and their adherence to the Canadian Kennel Club code of ethics, you risk undermining the preservation of purebred dogs....dogs that have jobs and duties that enhance human experiences like Service dogs, Diabetic alert dogs, Therapy dogs, Search and Rescue dogs, Military dogs, Police dogs, Detection dogs, Herding dogs, Mobility dogs, Guard dogs, Guide dogs, Bomb detection dogs, Hearing dogs, Cadaver dogs, Disease detection dogs and the list goes on. It is unfair to conflate ethical, regulated breeders with less accountable practices, such as those involving pet store sales, and impulse purchases which this motion needs to address. Responsible breeders do not contribute to any increase in local shelters or rescue organizations. This was recently proven by DNA testing of US shelter dogs with minimal or absent purebred dogs entirely. Thank you for your time.

The development of a resilient healthy adult dog relies on good genetics, early learning, and pre/postnatal environments. Studies, such as McMillan et al. (2013), demonstrate that dogs obtained from pet stores, as opposed to noncommercial breeders, are significantly more likely to develop a range of behavioural issues. As a trainer, I see firsthand how hard it can be to reverse this damage through training and behaviour

This is a critical first step toward managing pet overpopulation and reducing financial incentives for commercial breeders. This motion is a step toward positive change, but it is just the beginning. While there may be only one retailer selling companion animals in Calgary, the broader issue lies in the unregulated breeding practices that continue to feed this cycle. At present, anyone can breed animals and sell them for profit with little oversight. Although there are ethical breeders around, many are in it for the money, often providing poor advice and raising puppies in detrimental conditions. From "puppy parties" at rural farms selling unsuitable working dogs to urban families, to clients sharing stories of such sad conditions that they felt compelled to go forward with purchasing the dog to "rescue" them from the situation.

What we need, in addition to this motion, are regulations that prevent breeding operations from continuing unchecked. No one should be able to profit from litter after litter without consideration for the welfare of the animals involved or the education necessary to produce companion pets. Many believe it doesn't matter where a dog comes from until they find themselves overwhelmed by behaviour problems that could have been avoided.

Passing this motion would help protect both animals and consumers, and I urge the Committee to move forward in support of it.

Due to the extremely poor definition of abandonment in the Animal Protection Act of Alberta, Officers often cannot charge for abandonment, even when they know who was responsible. I support the Calgary Humane Society (even adopted a dog from there, once) and AARCS, but I also support ETHICAL, RESPONSIBLE breeding of purebred animals for those that wish to own one. I myself do, he is of a rare breed of dog with only a handful of breeders in North America. I was screened by the breeder, I co-own him with his breeder, and her information is permanently attached to his microchip. I did hours of research over a number of months before going this route and made the best choice for me, for my life, as a normal person living in this city should be able to do. He is a healthy dog from parents who have had genetic and health screening performed by veterinarians with the results uploaded to a database, and he has a stable temperament. We do not go to dog parks, he is never left outside unattended, and we spend hours each week attending specialized training courses for competitive sport. The dog I adopted from the Humane Society a number of years ago was, to put it lightly, a bit of a dumpster fire - I loved him deeply, but he required daily Prozac to live a somewhat comfortable life and is part of the reason I have chosen to get a responsibly bred dog. Without being able to access a dog from a responsible breeder, instead of pulling a dog out of a shelter environment I simply would not have a dog in my life to the detriment of my physical and mental health. If the City wants to make a measurable impact on the amount of dogs in rescue or shelter situations, there should be low cost spayneuter programs with limited barriers to entry, support of Provincial legislation to prevent landlords from denying tenancy to renters with pets (ex: what Ontario has done). guidelines regarding the legitimacy of certain animal "rescues" (ie: prevention of retail rescue and guidelines for international rescues - if we have such a problem at home, why are we importing rescue dogs from Mexico, the Middle East, and Asia???), and working with surrounding rural areas to allow their participation in low cost spay-neuter programs as well.



WHEREAS Calgary Animal Shelters are currently at capacity due to higher than normal rates of pets being surrendered, with many reports citing the housing crisis as one of the driving factors for pets being surrendered;¹

AND WHEREAS Calgary has repeatedly experienced various pet populations being released into the public, resulting in feral populations of certain animals, which in some cases has resulted in growing populations of the animals in our communities suffering from extreme health concerns;²

AND WHEREAS to ensure the health and safety of pets that are for sale, many municipalities have ended the practice of selling certain pets in retail locations due to the risk of animals being born in "mill" environments being sold in pet stores. In the past, Calgary has successfully closed several puppy mills with the support of Animal Protection resources like the Calgary Humane Society.³

AND WHEREAS Major cities in Canada that have already banned the sale of certain animals, like puppies, in pet stores include Richmond, Vancouver, London, Toronto, Montreal, Brampton, Kitchener and Waterloo:

AND WHEREAS More support is needed from the Province of Alberta in updating the Animal Protection Act to better define the conditions in which animals can be housed and sold from:

NOW THEREFORE BE IT RESOLVED that Council direct Administration to bring a report to the Community Development Committee by Q4 2025 that;

- 1. Reviews the sale of pet dogs, cats, and rabbits that are not sourced from local shelter or rescue organizations including, but not limited to:
 - a retail sales ban.
 - advocacy to the Government of Alberta.
 - a public education campaign,
 - bylaw updates and additions,
 - or other policy instruments.
