Dear Honorable Mayor Gondek,

I am writing on behalf of Pets Canada to express our concerns regarding the proposed motion to ban the sale of dogs, cats, and rabbits in Calgary's retail environments. While we understand the intent to address animal welfare issues, we believe that an outright ban would be an ineffective strategy, leading to unintended consequences.

Key Concerns:

1. Consumer Choice and Responsible Sourcing:

Banning retail sales limits consumer options to acquire pets from reputable sources.
Many pet stores collaborate with responsible breeders and adhere to stringent standards to ensure animal health and well-being.

2. Economic Impact on Local Businesses:

 The proposed ban could adversely affect local pet stores, leading to potential closures and job losses. For instance, in New York, similar legislation resulted in significant economic challenges for responsible small pet retailers, with some forced to shut down due to the inability to compete with online suppliers.

3. Unintended Consequences:

 Restricting legal avenues for purchasing pets may inadvertently drive consumers towards unregulated online markets or unscrupulous breeders, exacerbating the very issues the ban seeks to mitigate.











4. Impact on Animal Shelters:

- While such bans aim to reduce shelter intake and improve animal welfare, evidence suggests that they may not achieve these goals in the long term. For example, during the COVID-19 pandemic, there was a surge in pet adoptions, followed by an increase in pet surrenders due to owners' lack of preparedness and resources. ¹
- Shelters have cited reasons for owner surrendered pets has directly been related to the ever-increasing cost of caring for a pet. ²
- This indicates that limiting purchase options without adequate education and support may not effectively reduce shelter intake or improve animal welfare.

Recommendations:

Safe Sourcing:

 Allowing the continued sale of dogs, cats and rabbits by registered local pet businesses gives the city the ability to have traceable and inspected sources of pets. Removing the retail framework, will indeed drive Calgarians to other unregulated sources. Working with the existing framework helps the city to ensure the wellbeing its pets.

Enhanced Regulation and Oversight:

 Implementing stricter regulations and regular inspections for pet retailers can ensure that animals are sourced responsibly and treated humanely, without eliminating consumer choice.

• Public Education Campaigns:

 Educating the public on responsible pet ownership and the importance of sourcing pets from ethical breeders or adoption agencies can address welfare concerns more effectively.

Support for Shelters and Rescue Organizations:

 Providing additional resources and support to local shelters can help manage overpopulation and promote adoption without imposing restrictive measures on the entire pet industry.

We urge the Council to consider these points and explore alternative solutions that address animal welfare concerns while preserving consumer choice and supporting local businesses. Pets Canada is committed to collaborating with the City of Calgary to develop and implement policies that promote responsible pet ownership and ensure the well-being of all animals.

Subject: Opposition to Proposed Pet Ban

As the owner of The Top Dog Store—the only business directly targeted for closure under this proposed pet ban—I urge you to dismiss this agenda item immediately. This matter was thoroughly addressed in the 2022 Responsible Pet Owners Bylaw, and I waited until it was passed so I could sign a long term lease with confidence that my ethical, responsible business would not face such unwarranted disruption.

The Top Dog Store has consistently operated to the highest standards, providing healthy, happy puppies to loving families. We maintain an A+ Better Business Bureau rating, hold an Attestation of Exemplary Animal Husbandry Best Practices from Pets Canada, and have received hundreds of five-star reviews from satisfied customers whose lives have been enriched by our puppies.

This proposal would devastate not only my business, my family and employees but also a broad network of local businesses, including our Alberta-based breeders who operate under strict ethical guidelines, veterinarians, groomers, dog walkers, daycares, our landlord, and sadly, even other pet stores.

Our business should be commended—not punished—for our exemplary animal care practices that include breeder inspections to ensure optimal care, retail kennel operations that operate under veterinary supervision, expert puppy socialization and care by trained staff, and exemplary homing practices that ensure smooth puppy transitions into loving homes.

It is unacceptable that this proposal has appeared without any consultation with the very business it targets for closure. Claims that this ban would address animal rescue or pet overpopulation are false. Equally troubling is the offensive implication that my animals come from unethical "mills." The reality is that this ban does nothing to address the real issue: online platforms like Kijiji, where anonymous backyard breeders operate without oversight, scamming buyers and providing no support for pet care.

If council truly seeks to improve animal welfare, focus on these unregulated sellers—not my reputable, regulated, and transparent business. I invite any member of council, especially the alderman who introduced this item, to visit my store, meet our team, and see firsthand the care we provide.

I ask council to stand for fairness, facts, and responsible business practices by dismissing this proposal. My store, my team, and our community deserve better. Sincerely,

A full out ban is not going to be the solution and it will come with it's own set of problems. A ban like this won't actually do much to stop the backyard breeders because they generally find ways around things like this.

This will actively hurt the reaponsible breeders who dedicate their lives to giving their dogs the best care, make all their decisions based on what is both best for the breed, the dog and their puppy owners. They strive to breed healthy animals with good temperaments who are raised so that they will have the best start in life and go to being a really good lifelong pet. They screen their owners carefully and usually have a relationship with all their puppy owners for life. By stopping ethical breeders, by default you are only supporting unethically bred dogs. The dogs in rescue will not be from ethical breeders because they have a contract saying that at any time in the dogs life that should the owner need to find a home that they will always take the dog or help find a good home. That their puppies will not end up in rescue, auction etc.

That means the dogs in rescue are coming from backyard breeders and careless ownership. If those are the only animals allowed to be sold, that means that society is only supporting the initial person who was responsible for that puppy - which is the irresponsible or careless breeder. Good breeders will stop. Well bred dogs bred purposefully for their good temperament will disappear and only dogs remain who were not bred for health and temperament remain. Many shelter dogs have been traumatized and come with an array of health and mental issues. Many of these require great resources financially and emotionally to rehabilitate, and some will remain damaged for life. In the end, it will still result in terrible things for the animal and the owner. A lot of owners aren't experienced enough to handle these situations.

Rather than a blanket ban, a study should be done first to find out where the dogs are coming from largely and programs put into effect to help keep those populations in check. Owners should still have the option of choosing who they want to support. They should also be expected to do their homework and be prepared to wait for the dog that is the best fit for them. Rescue dogs are still a purchase. Money changes hands. Whether or not they make a profit isn't what makes it a purchase. Most good breeders often are very lucky if they make any profit either after all the health testing and other expenses also.

Educating the public to be able to recognize a good breeder and what is involved in contracts would be a good start.

This just can't be a black and white solution.
