I would like to open stating the City hiding the Public Hearing sign amongst the large tree growth is deceitful. Our small community does not have the space or infrastructure required to accommodate any more high density housing. Traffic is already a nightmare in the area and specifically along that road due to 3 large, 4 storey apartment complexes within 2 blocks. The road, 24th Street, is a two way, small community road and is the only access to the main road, 162 Avenue, for that entire area. Traffic becomes abysmal regularly but worse in the winter along 24th Street. People wait far too long just to turn onto 24th Street to continue to wait to leave the community. Glenmore Christian Academy is also on that street and they are expanding which will cause more traffic along with another school going in on the West side of 24th street further exacerbating traffic and infrastructure chaos. The density of this community is such that during rush hour, city busses are too full to stop and pick up more passengers leaving our kids waiting for later busses to pick them and finally get them to their designated high schools late. During our harsh winters this is unacceptable. This neighborhood has been packed with more density than it is capable of managing with the multiple large 4 storey, high density apartment complexes, multiple row house complexes, duplexes and all of the single family homes, it simply cannot manage any more homes, certainly not more high density housing. The City needs to add the density in the neighborhoods where it is already planned, such as Seton, and where the density is such that the community is able to seamlessly assimilate the growth not in communities where traffic and unmet infrastructure needs are already a massive problem.
