I am a business owner within the 17th Ave Retail & Entertainment district and am not in agreement to the increases submitted in the budget by the BIA committee. There has been no yearly AGM or input sought from the business owners as to where the money should go. We are struggling what with all the costs going up (rent, food, taxes, etc.) and we all have to do our own advertising and promoting our business. Many businesses during Stampede did not get patios (which BIA budged for) even though emails were sent to them requesting this. We had to spend our own money to buy the lumbar, pay contractor to assemble and dismantle and pay storage costs. This is one of the services we pay for. We are not getting a return with the money we already pay and there has been no additional beautification in the area. Additional staff have been hired by the BIA and businesses have no idea where the money collected is going. There is lots of theft on 17th Ave. Signs are being stolen, thefts by customers, etc. which is an additional cost to businesses, not counting costs to run our businesses on a daily basis. Many businesses have closed and can barely make ends meet. Collecting more money from us when it is not benefiting us is not fiscally responsible. At a time when more businesses are closing and cannot afford the rent, and we are not benefiting from the BIA services, asking for an increase in the BIA taxes is not reasonable.

I am a business partner at an establishment within the 17th Ave Retail & Entertainment district. We are not in agreement to the increases submitted in the budget by the BIA committee. At a time when businesses are struggling to make ends meet and many are closing because of high costs, it is not reasonable to increase the BIA taxes. We are also concerned that money is collected from businesses but yet we are not consulted with where our money is going. There has been no annual meetings and no audited accounting statements where the money has been spent. No input from the business owners as to where the money should go and address the needs of businesses in this area. We are struggling what with all the costs going up such as food, rent, advertising and taxes to name a few. During Stampede, we were advised that money collected would be used towards patios (which BIA budged for) and many of us had to pay out of pocket for this. Absolutely no assistance from the 17th Ave Retail and Entertainment District. Although they focus on signature events and this brings people out, there is no extra revenue to businesses. The additional traffic causes more parking issues and people don't spend money at the businesses. Investing in more full time staff is not justified and there is no beautification to the area. Homeless population is getting to be more of an issue in addition to thefts of outdoor signs, flower pots, etc. We have to spend money out of pocket for all the losses incurred. We as businesses are not getting anything extra out of the funds collected and we question further justification to increases. We are not getting a return with the money collected from the BIA tax. They want to hire additional staff and there is no need for this. We are recommending no to additional increase in the BIA tax. Collecting more money from us when it is not benefiting the 17th Ave Retail and Entertainment District is an issue. Thank уоц.
