Re: Request to delay GamePLAN

Dear Major and City Councillors,

As you are aware, GamePLAN was just released to the public on Feb. 6, 2025. Overall, Elbow Park Residents Association applaud the City's commitment to improve the availability of sports and recreational facilities for Calgarians, but the timeframe for consideration before the next city council meeting on February 25<sup>th</sup> is insufficient. This timeline does not allow for communities and citizens to understand the goals and impact of this new strategy document. For example, there is uncertainty about GamePLAN's impact on smaller recreational facilities in communities that provide valuable programs and are often more accessible than a megaplex.

It seems prudent that a strategic plan for recreational facilities of the magnitude of GamePLAN, both monetarily and scope of impact, should be given more time for deliberation and contemplation. This would allow for better clarity and communication on what GamePLAN's impact will be, and how it fits into the overall plan for our city going forward.

Respectfully, we request that council refers GamePlan back to administration for fulsome community dialogue on the proposed changes to Calgary's recreational offerings. Please allow more time to provide clarity on how this will be a success in the coming years.

I already made a submission, but subsequently became aware that we will not able to speak to this Consent Agenda item. I was able to speak at the Committee meeting, but the full council was not there. I believe that there are some on the Council that were not in attendance that feel that spending totalling upwards to \$6.5 Billion in the next 25 years should have some public input to the full council. I am strongly in favour of the main premise of GamePLAN - that we need to invest significantly and on an ongoing basis in recreational facilities. However, I believe that some of the parameters driving that investment are problematic - the focus on larger megafacilities, not investing in maintaining aging facilities, the assumption that many in the public will be willing to drive significant distances to participate in basic fitness, targeted investment locations not aligning with the projected growth and the expectation for fewer cars as we densify, being some of these concerns. I want assurances that as we progress over time there will be opportunities for input and investigation into different parameters form investment.

Dear Madam Mayor and Members of Council,

The Canadian Council of the Blind is a non-profit organization of blind adults. The Calgary Chapter has just over 60 members. The main barrier for the blind to attend public swimming is the public. Complete disorientation happens in open water where there are no tactile clues to guide you. Most people with blindness give up on swimming altogether because the public does not understand this. The Inglewood Pool has been perfect for us for several reasons. Its central location works as we have members living in all four quadrants of the city. With the blind, familiarity improves function and we have been able to learn to navigate the dressing rooms and pool deck as well as the pool. We are able to have exclusive swims with only our members in the pool and the dressing rooms, so there is no public in our way getting frustrated with us. I have heard members comments such as, "This is the most comfortable swim I have ever had." Swimming is an important life skill to have and many other activities are safer and more enjoyable if you are competent in the water. The large complexes actually diminish our independence as we would require a sighted guide even to find the dressing room. Even if they rope part of the pool for us, there is still plenty of public to avoid. We have members with multiple disabilities as well and the small Inglewood Pool works for them. The large complexes are great but not for everybody. Please think of those Calgarians for whom a smaller facility is best. Thank you for your time and attention.

The smaller city operated pools around Calgary such as Killarney, Glenmore, Renfrew, Inglewood and Shouldice plan an important and critical function to Calgarian's daily lives

As a born and raised Calgarian I have interacted with these pools my whole life. As a child I had swimming lessons in them, as a teen I participated in competitive swimming including practices at Canyon Meadows, Glenmore and Killamey pools and as an adult I use them for personal health. Now, as a parent, I also use City pools for swim lessons for my two children.

While I appreciate that new facilities are needed, and there is an appetite for multi-use facilities, the role and function the older pools play in daily Calgarian lives is being understated and undersold. New facilities do need to be constructed, but it cannot come at the expense of the existing facilities. The lengths that I have to go to in order to attempt (!!) to register my children in swim lessons, often unsuccessfully due to massive demand and chronic undersupply, is unacceptable. We need more flat water pools and pool time, not just different facilities.

If the City continues down the path of closing small, local, flat water facilities and consolidate into fewer multiuse facilities will not improve service, it will remove local access and make utilization more difficult for Calgarians. This measure needs to be rethought.

I have been swimming recreationally and competitively since childhood. My first experiences in swimming were taking lessons at a local pool, during which I showed an aptitude for the sport and joined a local swim club. This was followed by an increased level of commitment to the sport throughout my teen years and culminated in a scholarship to the U of C, during which I captained the men's swim team and represented Canada internationally as an athlete while also obtaining a Bachelor's of Commerce in Accounting and eventually a CPA designation. I believe that the friendships and skills that I developed as a swimmer (hard work, perseverance, focus, commitment, etc.) have directly enabled me to be a productive member of my community into my adulthood. This developmental process was in turn facilitated by easy access to a small local pool in my community during my childhood. This experience would have been markedly different without that level of access - it's likely that without this easy access to a local facility my swimming career would not have progressed beyond the basic lesson phase as rides to and from a larger facility would not have fit with my parents' busy schedules. I believe that all Calgarians deserve access to these same opportunities.

I strongly support the City significantly increasing funding as outlined in the Making Waves GamePLAN to build new recreation facilities that meet both current and future demand. The City of Calgary's facilities and programming are overcrowded, with high demand and long waitlists, particularly for swim lessons and lane space.

As a former competitive swimmer for 15 years, I have seen firsthand how pool space has been at a premium in cities across Canada for decades. Now, as a parent trying to enroll my toddler in swim lessons, it's disheartening to see such limited class availability, with spots filling up instantly—like trying to get tickets to a major concert.

Looking at pool schedules, it's clear there is a disconnect between facility hours and public needs. Most pools are open up to 16 hours on weekdays but only 8 hours on weekends, which does not align with the schedules of families—especially those with infants and toddlers who have fairly universal nap and bedtime routines.

Given the high demand for classes, how can the City consider shutting down existing pools like Inglewood and others? Is this due to a lack of lifeguards? A shortage of instructors? Or a reluctance to adapt to community needs? If pools are underutilized, the solution should be to adapt—not to let them die. If City-run programming can't keep up with demand, why not make it easier for 3rd parties such as clubs and private providers to use the space to better serve the community?

The City is presenting two conflicting narratives: on one hand, pools are supposedly underutilized and too old to maintain, yet on the other, tens of thousands of people are waiting for more access to swim programs. Which is it?

Even though GamePLAN suggests that new facilities will be more cost-effective than maintaining older ones, will two new pools be built before an old one is closed? The problem shouldn't have to get worse before it gets better.

Specifically, the Shouldice pool is used by our group 2x per week. It is conveniently located for those of us living in the 'inner city' ( I live in Glendale). Its catchment area is quite large, I think.

It would be shame to have to think about driving to the outer parts of the city for recreation. We have seen this before at Beltline and Inglewood where older facilities are shuttered and patrons have to either travel a significant distance to a pool or resort to more expensive ones like MNP.

Smaller groups like ourselves can afford to go to smaller facilities whereas a mega pool would undoubtedly come with a steep rental fee. Also, with new districts being built just west of Shouldice (e.g. Paskapoo slopes), there will undoubtedly be demand for the pool due to convenient access.

I would ask Council to reconsider the proposed plan to close the smaller facilities to ensure patrons have reasonable access to recreation facilities. Citizens of Calgary should not be denied access to facilities because of where they live.

However, in researching for more pool space for swim lessons these pools are not open on the weekends which severely limits the pool availability for all citizens. Furthermore, with more pool space available, that allows for more staff to be hired which in turn opens job opportunities for citizens. The demand for pool space will continue to grow, especially with the growing number of families in Calgary, and I believe that we as a city have to respond accordingly in order to foster the well-being and needs of our citizens. Additionally, with the recent news of Vecova closing at the end of June this year, Calgarians need inner city pools to support the special needs community that mega facilities cannot provide alone. These families face not only financial challenges but also difficulties finding inclusive programming and accessible facilities in a community near them. We need these city pools so that these individuals, along with other members, are given the chance to fully participate in community life while fostering life long swim skills. These pools are also able to provide a quieter, calmer environment for those individuals with sensory/sensitivities that will only be exacerbated in larger crowds. The continued operation of these pools should be fully considered since most of these families attend the pool with privately hired aides, therefore, longer travel distances and possibly higher fees only extends the financial burden felt by these families. The larger facilities are indeed a great addition to Calgary's list of amenities, providing a multitude level of high quality competitive aquatic opportunities. On the other hand, majority of citizens need the smaller grassroots facilities closer to home to ensure we limit the barriers in accessing aquatic activities.
