Dear Mayor and Council,

On behalf of United Way of Calgary and Area, I want to express our gratitude for your service to Calgarians and dedication to making Calgary a resilient city. For 85 years, <u>United Way</u> has worked to build a community where everyone thrives. We cannot achieve that goal alone. The City of Calgary has been an invaluable partner, adopting the <u>Enough for All</u> strategy, working with us to establish <u>Community Hubs</u> in priority Calgary neighborhoods and collaborating on <u>Action Table Calgary</u>. In 2023, because of our partners such as The City, we helped over 220,000 people in Calgary and the surrounding area achieve their full potential!

Recent years were challenging for Calgarians. Living in Calgary has become more expensive, and unemployment has remained high, rising above 8% this summer. Wages in Calgary have lagged during inflation. Rent is becoming unaffordable for many Calgarians, as the average cost of a two-bed apartment has grown from \$1,355 in 2021 to more than \$2,000 per month in 2024. Owning a car is becoming unaffordable, as average auto insurance premiums in Alberta are more than \$1,600 per year.

As many as 130,000 Calgarians live in households whose earnings put them below Canada's official low-income cut-off, meaning their income is inadequate to cover the daily necessities of life, such as food, shelter, clothing, and transportation.

To maintain a resilient and caring Calgary, I respectfully urge Council to vote to fund the Low-Income Transit Pass program and the Downtown Safety Leadership Table's recommendations, as these are fundamental investments in Calgary's people and future. I also encourage Council to identify and secure adequate, long-term, predictable and stable funding for the Low-Income Transit Pass program on a permanent basis.

Calgary's Low Income Transit Pass program is a lifeline for many households and is a big part of The City's Fair Entry policy and programs. It allows Calgarians to go to work, school, medical appointments or shop for groceries. It also remedies social isolation and loneliness by enabling people to be part of daily life in their communities. As we emerge from Canada's biggest cost of living increases since the 1980s, we cannot leave anyone behind. Fully funding the Low-Income Transit Pass program through the end of 2025 will help make certain that all Calgarians can fully participate in economic and social life.

It is important for Council to examine how to fully fund the Low-Income Transit Pass program beyond 2025 through existing City resources or partnerships with other levels of government. People across Canada and worldwide come to Calgary because it is a welcoming, vibrant city and a wonderful place to raise a family, build a career, and find your community. Building a life in Calgary should not only be the privilege of the wealthy. Our city needs to work for all Calgarians, and affordable transit is an essential tool that gives Calgarians a chance to overcome poverty and help build our city.

Just as affordable transit is crucial for our community, ensuring a safe environment is vital for everyone who lives and works downtown. Thank you for establishing the Downtown Safety Leadership Table (DSLT) and encouraging Council to fully fund and implement the DSLT recommendations. Like all of Canada's large cities, Calgary is grappling with a surge in the

number of people experiencing homelessness and who are struggling with mental illness and substance addictions. There is no quick and easy way to help and lift every Calgarian struggling with these challenges. However, the DSLT's recommendations are a crucial start. If fully implemented, the Table's recommendations hold the potential to save lives and make downtown a safer, more welcoming place for everyone. While implementing the DSLT's recommendations requires City Council to spend in the short term, these changes will save lives and save in the long term by reducing the use of police and emergency services and help restore downtown Calgary's vibrancy.

Decisions about spending public money are never easy. All Calgarians feel the effects of our country's cost of living crisis. I know from experience that by working together, we can lift Calgary's most vulnerable residents by giving them the tools to change their lives and reach their potential. These investments offer Calgarians a hand up by giving them the opportunity and the means to leave poverty, escape homelessness, and thrive in Calgary.

Despite the evidence to support a green line, Council's handling of the Green Line has been abysmal. 1/4 of the line with fewer stops and 50% more than the ENTIRE line was supposed to cost is fiscal mismanagement, inflation or not. It is truly enough. TALK to the province and get funding for the transit passes. YOUR JOB is to WORK WITH the provincial government, Full stop. It also seems we were told there were excess funds 'saved' which should be available for water infrastructure. Transparency is pretty cloudy at the moment, as is the public's support of the majority of Council's actions. The money spent on a re-zoning hearing was how much? It should have been included with the upcoming Civic election in a referendum and you should have negotiated around this with the feds on this instead of agreeing to rezoning before the hearing was even held (further, the feds should be coming in through the province, not direct to the City, but that is yet another issue). You are spending OTHER PEOPLE's MONEY, and doing so in a manner that does not instill confidence. Comparing to Toronto and Vancouver is out of line. They have serious drug and immigration issues that we have only a fraction of (and ours is bad enough and needs addressing), further, Edmonton's Council is quick to spend taxpayer money as well, so not buying that comparison. Start showing you want to lead, be responsible fiscal stewards. Do you even know how? Start with a review of EVERY department (including ZERO based budgeting). 

It has recently come to my attention that the City of Calgary is proposing to reinstate annual fees to local hospitality businesses in regards to seasonal extended patios. Fees that in many instances will mean thousands of dollars out of pocket for local operators.

I would implore the city to carefully consider the impacts that this decision will have on both the local businesses, as well as the hard working, younger demographic that both supports, frequents and is often employed by.

For the past few years, this program has been instrumental in providing the city (and people within) a vibrant and engaging atmosphere during warmer months. A handful of destinations where the public can go on foot and socialize, enjoy the outdoors in a celebratory fashion, put our phones down and enjoy the company of others, while supporting local businesses at the same time.

By reinstating these fees, you are not only further damaging the potential profitability of these local businesses, which have been decimated by tax increases, labor costs, cost of goods, insurance costs, utility increases but you are also putting at risk the high number of seasonal jobs that your current program is helping to create.

By charging small businesses thousands of dollars to operate temporary picnic tables in front of their establishments, you will quickly see the number of operators taking part in this program diminish, taking employment opportunity with it. This decision hurts your local small business sector, as well as the hard working students (in many cases) who rely on these seasonal employment opportunities to fund their ASTRONOMICAL costs of living that have become a reality in Calgary.

This program was one of the only shining lights left in the hospitality industry where businesses had a chance to temporarily increase capacity and capitalize on the high traffic visits which the program helped to drive. It is one short period of time in the year where the opportunity to claw back some of these out of pocket increases is afforded to small businesses and in turn create jobs for the people who require this seasonal income.

I would strongly suggest that the City of Calgary look elsewhere for the required funds rather than back into the pockets of small businesses and the people who help them survive.


