I wanted to comment of the filing but cannot seem to find the link to do so. As there will be 3 hidden driveways merging onto our street I am very concerned about the high risk of accidents. The speed of drivers on our street (which is well above the posted 50kmph) along with the blind curve and steep incline on the road, will be very risky for these new residents to navigate when trying to come on to Springbluff Blvd SW. I strongly recommend the following:

1. A hidden driveway sign for both directions on Springbluff Blvd SW; and
2. The speed limit on Springbluff Blvd SW / 77th Street to be reduced to 40 Kmph.
