## BYLAW NUMBER 26M2025

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 11M2019 THE PARKS AND PATHWAYS BYLAW

\*\*\*\*\*

**WHEREAS** Council has considered report CD2025-0038 and deems it necessary to amend Bylaw 11M2019, the Parks and Pathways Bylaw;

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. Bylaw 11M2019, the Parks and Pathways Bylaw, as amended, is hereby further amended.
2. In section 2(1):
  - (a) in subsection (a), after the words “headstone, memorial marker,” the following is added:  
  
“stairs, seasonal lighting, engineered structures;” and
  - (b) after subsection (g), the following is added as subsection (g.1):  
  
“(g.1) *landscape maintenance services*” means services including turf maintenance, mowing, maintenance of pathways and other surfaces, irrigation, litter control, debris picking, vegetation planting and vegetation bed maintenance;”.
3. Section 3, including the header “SCOPE”, is deleted, and the following is substituted:

#### **“APPLICATION**

3. (1) This Bylaw applies to all *parks*.
  - (2) Sections 22(2), 24(1), 24(2), 24(3), 29(1)(a) and 29(1)(b) of this Bylaw do not apply to employees, agents or contractors of the *City* engaged in *landscape maintenance services* that are within the scope of their employment duties or contractual obligations.”.
4. In section 9:
  - (a) Subsection (1)(p) is deleted and the following is substituted as subsections (1)(p) and (1)(q):
    - “(p) camping or erecting camping tents; or
    - (q) erecting a temporary structure, including shipping containers and storage sheds.”.

5. In section 24, after subsection (4), the following is added as subsection (5):  
“(5) Despite subsection (4) above, employees, agents or contractors of the *City* engaged in *landscape maintenance services* may cut, irrigate, or apply fertilizers to any grass or other *park vegetation*.”.
6. In section 31:
  - (a) in subsection (c), the word “or” is deleted;
  - (b) in subsection (d), the period “.” is deleted and the following is substituted:  
“; or”; and
  - (c) after subsection (d), the following are added as subsection (e):  
“(e) install, operate, maintain or repair an *amenity*.”.
7. This Bylaw comes into force on the day it is passed.
