Previous Council Direction

Calgary Heritage Strategy (LPT2007-0064) directs though its *“Identify – Protect – Manage”* framework that significant heritage resources *“can and should be protected through designation bylaws”*

Legal protection through this framework (where agreed-to by a Property Owner) is also supported by the **One Calgary 2019-2022 Service Plans and Budgets** (C2018-1158), **Culture Plan for Calgary** (CPS2016-0867), and **Municipal Development Plan**.

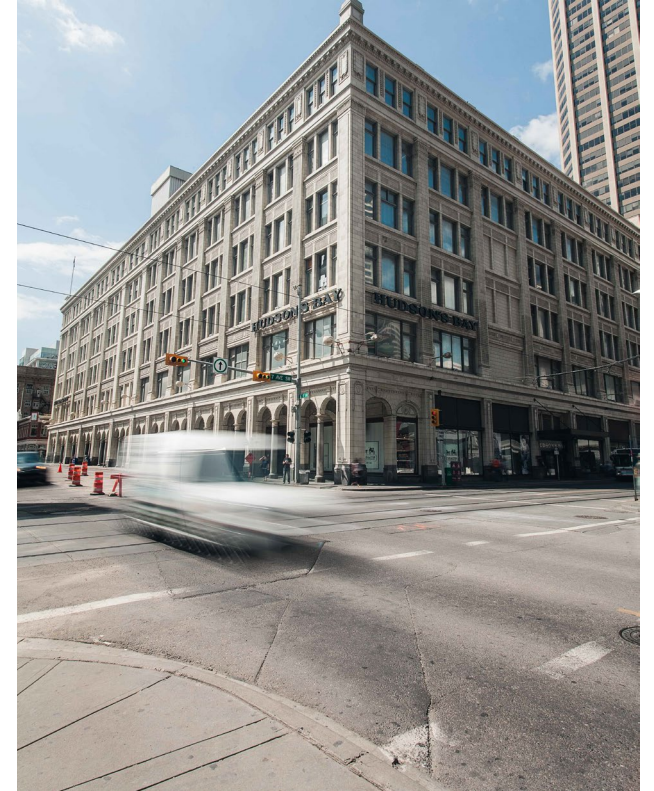

- Total designated sites (including report recommendations): 173



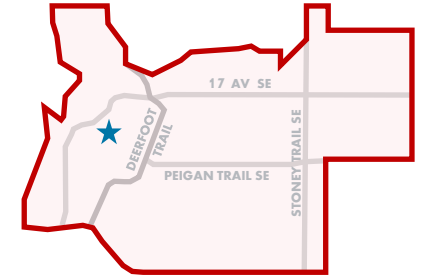

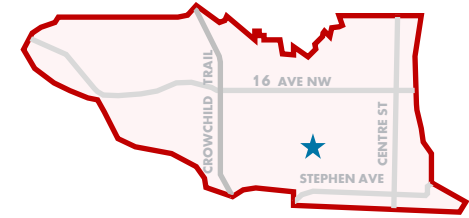
The Upton Residence

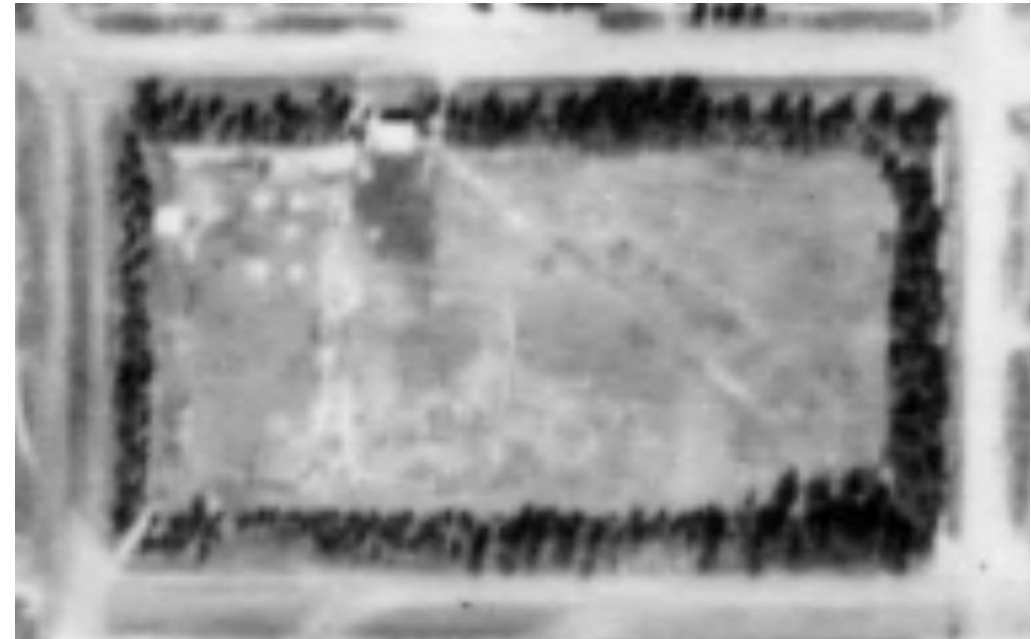
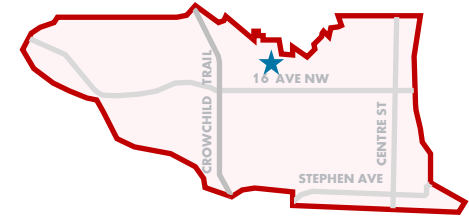
Capitol Hill Park

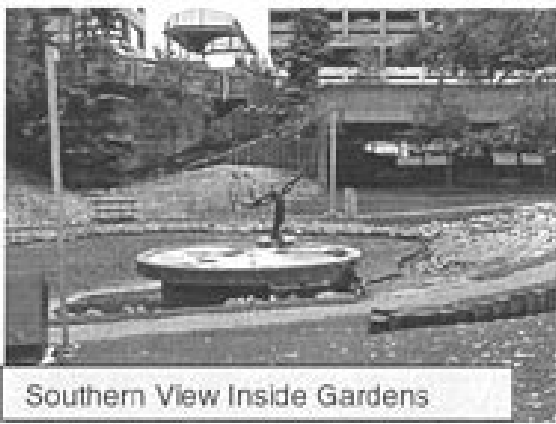
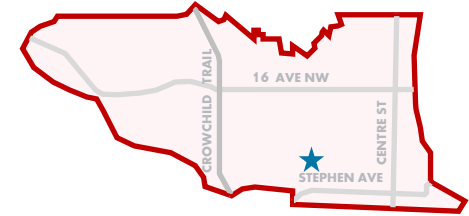
Century Gardens

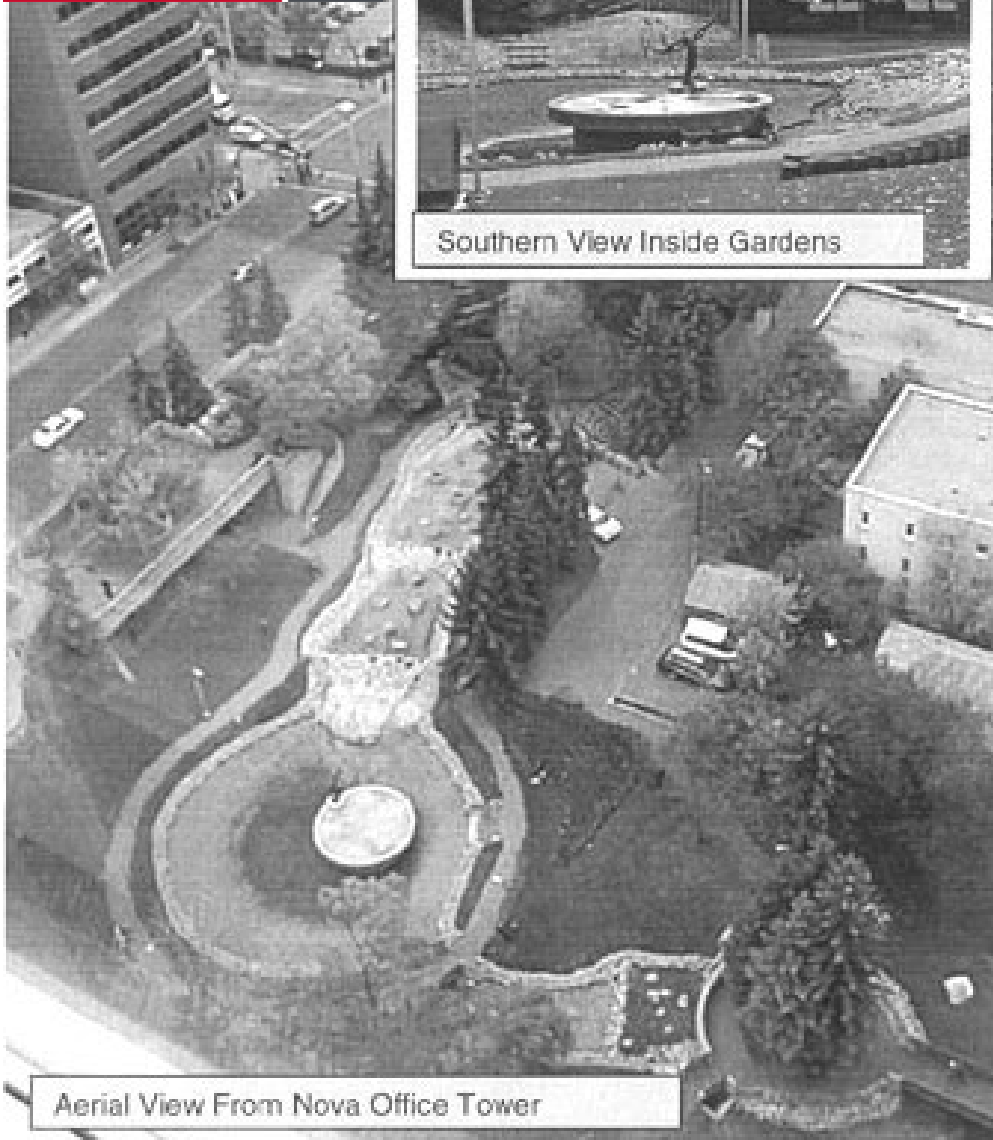

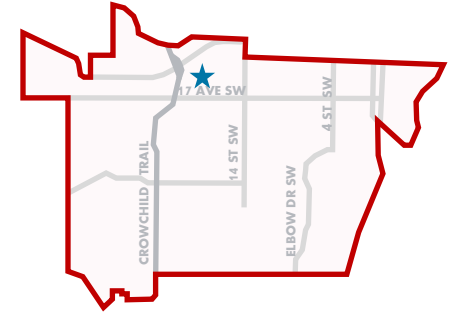
Triangle Park / Scotland Street Plot

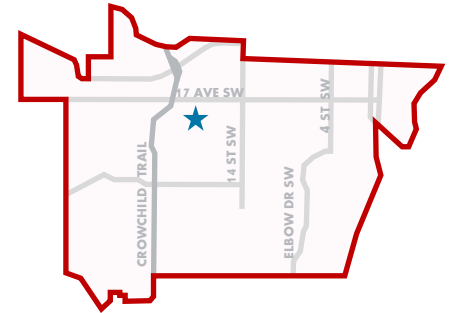
