

The objection to further restrictive covenants is that most structures have been modified / changed and suited to meet Calgary's growing property demand and therefore are not by definition heritage, rather they are old. The attached city map shows the area is under development to continue to make MISSION area a vibrant area. The area is zoned RM6 to further growth and dense-ification of the urban landscape. Despite the residences residing in a flood plane, flooding did not affect all of the properties. These low cost housing SEARS ROBUCK houses, along with multiple modifications are not pristine preservable structures, rather they are brief snapshot in time - like a Reliant K-Car or 1980 station wagon - good at the time but not a heritage article. multiple structures have new windows, modified interiors, or completely redone (examples on 2nd street) this is a

The current application to contact, make amendments to a 1911 structure located in MISSION (add a suite - been in existence for 20 years) is non-functional, with multiple requests for additional information, which is not part of the application, such as land-scape plan (which references google but does not accept - since withdrawn), placement of garbage cans, etc. multiple months to get a permit, but details of why it is required
