Did you conduct community outreach on your application?

The lot is currently identified under the South Calgary/Altadore Area Redevelopment Plan which does not allow rowhouses. This is in conflict with the land use bylaw which allows for rowhouses. The city of Calgary is currently working on the West Elbow Communities Local Area Plan (LAP) which is currently at Phase 4. The proposed development is in line with the West Elbow Communities LAP.

The city of Calgary has been working on updating the current Altadore Area Redevelopment Plan with and updated version known as the West Elbow Communities Local Area Planning. The city has engaged with the West Elbow Communities since September 19, 2023. As this minor amendment aligns with the West Elbow Communities LAP no outreach was done. The LAP shows the site of this project to be within an area that is looking to adapt "Low - Modified" development up to 4 storeys. It is also located within the proposed Neighborhood Connector area which represents the more residentially-oriented areas of the West Elbow Communities with entrances facing the street.

As this minor policy amendment aligns with the West Elbow Communities Local Area Planning there was no connection with any groups. - Concerns of the building height on a sloped lot and shadowing
- Increased density on the site
- Amount of available parking on the site and in the area

- -The proposed development is within the allowed building height of 11.0m and has been designed in a way which respects and follows the slop of the site.
