## BYLAW NUMBER 36M2025

### BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 25M2002, THE EMERGENCY MANAGEMENT BYLAW

\*\*\*\*\*

**WHEREAS** Council has considered EM2025-0632 and deems it necessary to amend Bylaw 25M2002, the Emergency Management Bylaw;

### **NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. Bylaw 25M2002, the Emergency Management Bylaw, as amended, is hereby further amended.
2. In section 2:
  - (1) subsection 2(f) is deleted and replaced with the following:

“(f) “Director” or “DEM” means the Director of Emergency Management;”;
  - (2) in subsection 2(h) the “.” is deleted and replaced by “,”;
  - (3) the following is added after subsection 2(h) as subsection 2(i):

“(i) “Municipal Emergency Plan” means the emergency plan approved by Council pursuant to section 11 of the Act.”.
3. In section 3:
  - (1) subsection 3(3) is deleted and replaced with the following:

“(3) The Committee shall:

    - (a) advise Council on the development of emergency plans and programs, as required by Section 11.1 of the Act;
    - (b) provide guidance and direction to the Agency;
    - (c) receive any reports and information provided by the DEM;
    - (d) amplify messaging provided by the DEM during Municipal Emergency Plan activations; and
    - (e) support the DEM, as requested, during Municipal Emergency Plan activations.”;

(2) the following is added after subsection 3(4) as subsection 3(4.1):

“(4.1) The Committee must meet at least once per year.”.

4. In subsection 4(3), after the words “powers and duties given to the City by the Act”, the words “and may further delegate any of those powers or duties” are added.
5. In section 5, the following is added after subsection 5(1) as subsections 5(1.1), (1.2) and (1.3):

“(1.1) The Agency is responsible:

- (a) for the administration of the City’s emergency management program;
- (b) for providing assistance and guidance to the Director to prepare for and mitigate an emergency in Calgary;
- (c) for reviewing the City’s emergency plan and operational annexes at least annually; and
- (d) for fulfilling additional responsibilities as set out in the Municipal Emergency Plan.

(1.2) The Agency must report to the Committee at least once per year to provide updates on Agency activities which must include an update on the Agency’s review of the Municipal Emergency Plan.

(1.3) The Agency shall use the command, control and coordination system prescribed by the Managing Director of the Alberta Emergency Management Agency.”.

6. In section 6:

(1) the following is added after subsection 6(2)(a) as subsection 6(2)(a.1):

“(a.1) approve operational annexes to support or provide further detail to the Municipal Emergency Plan,”;

(2) in subsection 6(2)(c), the words “, and” are deleted and replaced with “.”;

(3) subsection 6(2)(d) is deleted.

7. This Bylaw comes into force on the day it is passed.
