The Aboriginal Standing Committee on Housing and Homelessness (ASCHH) is dedicated to supporting the City of Calgary's Housing Strategy to increase the supply of affordable housing units, particularly and specifically for Indigenous peoples and other low and median earners in Calgary. As a community we need to continue addressing the gaps in housing due to the low vacancy rates and lack of affordable housing stock. In a landlord's market, prior affordable market rentals have become unaffordable, while other affordable units and neighbourhoods have been torn down and properties absorbed into a focus on gentrification to build out real estate agendas for wealthier populations. The flow of those younger populations moving out of rental properties into homeownership is no longer attainable impacting the rental market by decreasing vacancy rates. Housing is a basic human right, and in particular for Indigenous peoples who are over represented in homelessness, alternative and innovative responses to housing need is critical. Solutions that include shared knowledge, resources and expertise of those experienced affordable housing developers with the non-profit sector to increase access and retention of housing.
