BYLAW NUMBER 41M2025

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 34M2019 THE BELTLINE BUSINESS IMPROVEMENT AREA

WHEREAS Council, by Bylaw Number 34M2019, established the Beltline Business Improvement Area (the “BIA”);

AND WHEREAS section 8 of the *Business Improvement Area Regulation, AR 93/2016* (the “Regulation”) provides a process for the amendment to the boundaries of a Business Improvement Area;

AND WHEREAS a request has been received to amend the boundaries of the Beltline Business Improvement Area;

AND WHEREAS notice has been sent to every taxable business within the existing BIA, and every business that would be taxable under the proposed change in boundaries, in accordance with sections 8(2) and 8(3) of the Regulation;

AND WHEREAS the Board of the BIA has consented to the change in boundaries, and the taxpayers within the BIA and the proposed new area have been provided with an opportunity to make representations to Council prior to second reading of this Bylaw in accordance with section 8(1) of the Regulation;

AND WHEREAS Council has considered report C2025-0586 and deems it necessary to amend Bylaw 34M2019, the Beltline Business Improvement Area Bylaw;

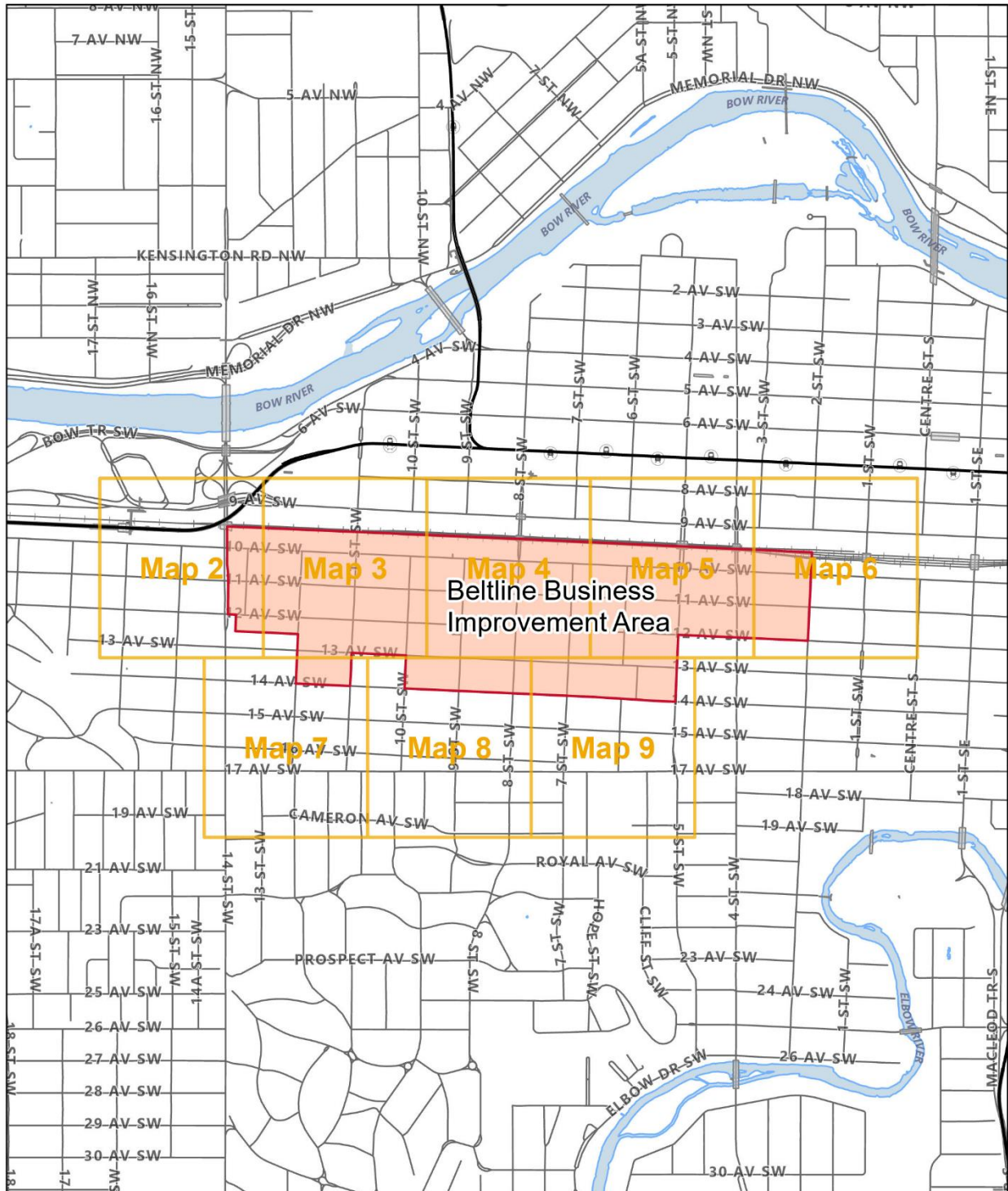
NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 34M2019, the Beltline Business Improvement Area Bylaw, is hereby amended.
2. The boundaries of the Beltline Business Improvement Area are amended by deleting Schedule “A” in its entirety and substituting the following in its place:

Map 1 - Overview

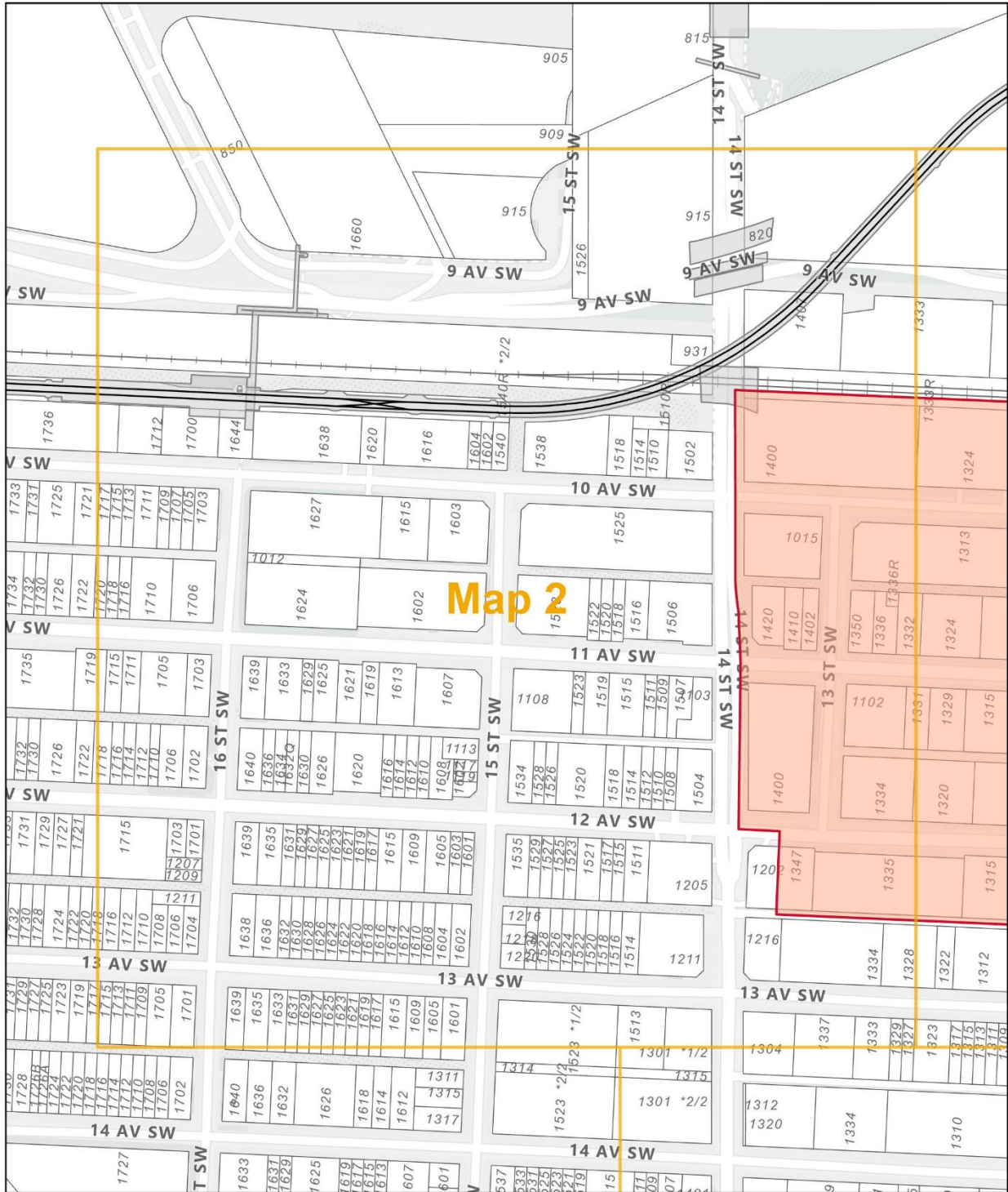

Map 2 - Detail

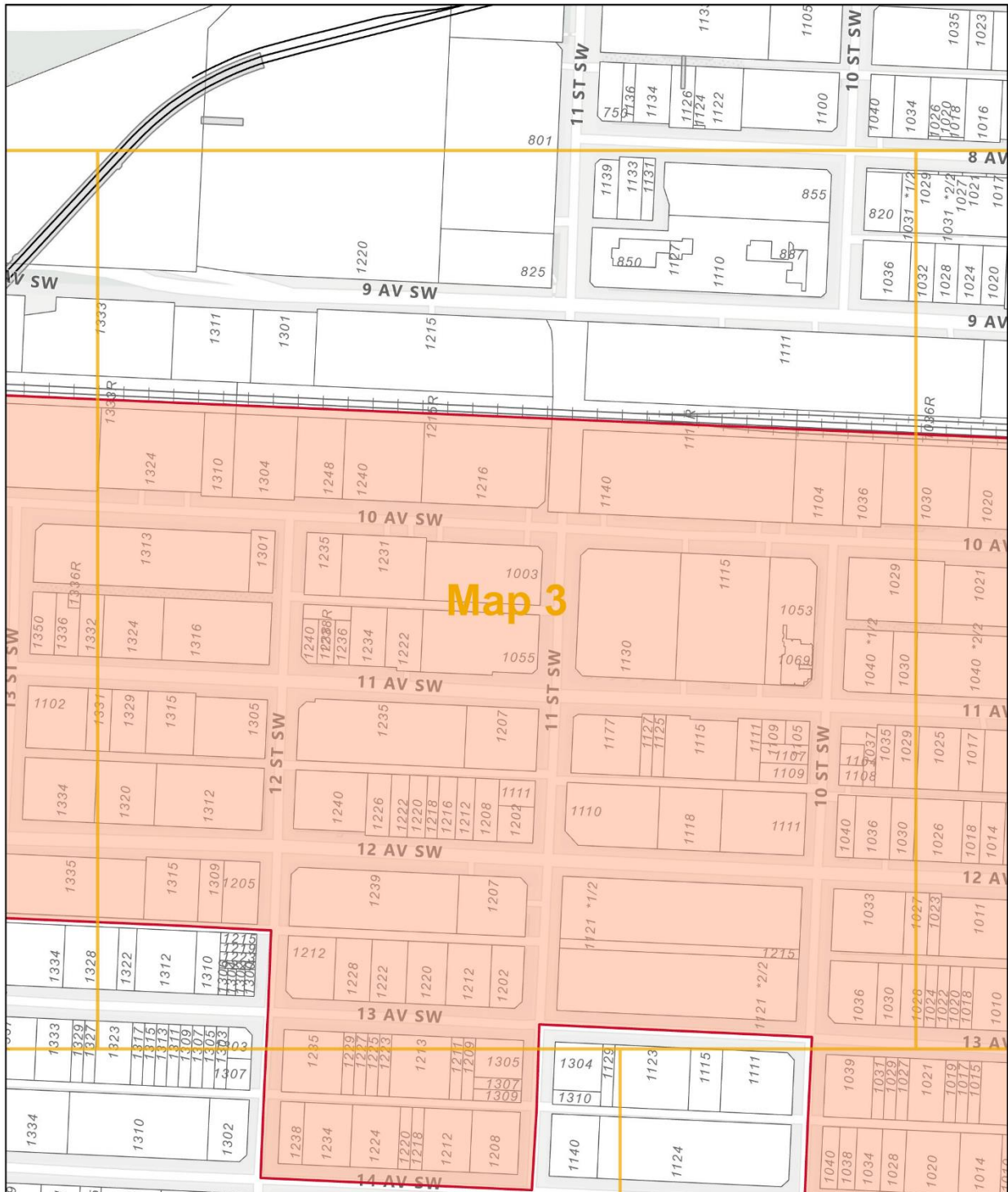

Map 3 - Detail

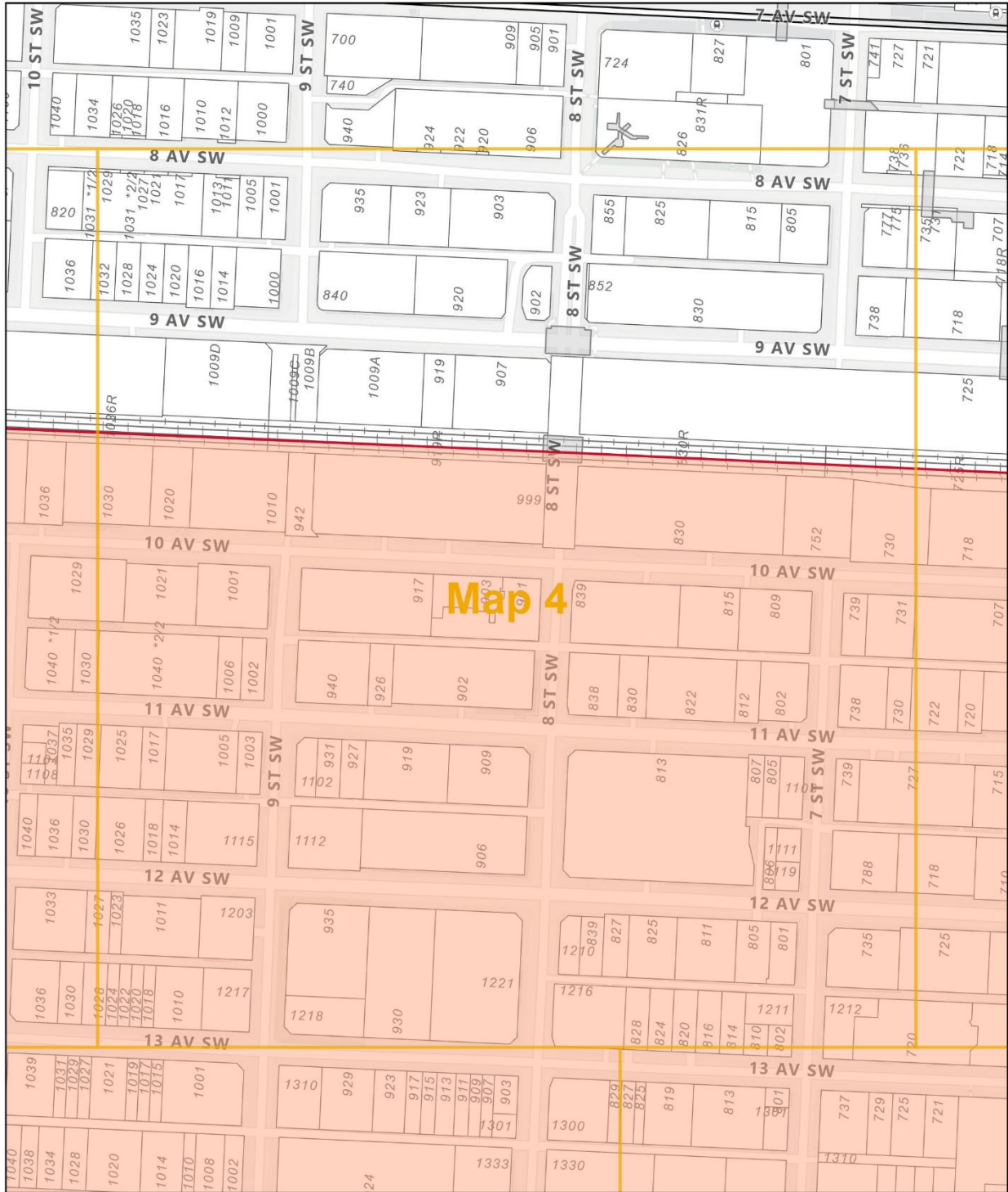

Map 4 - Detail

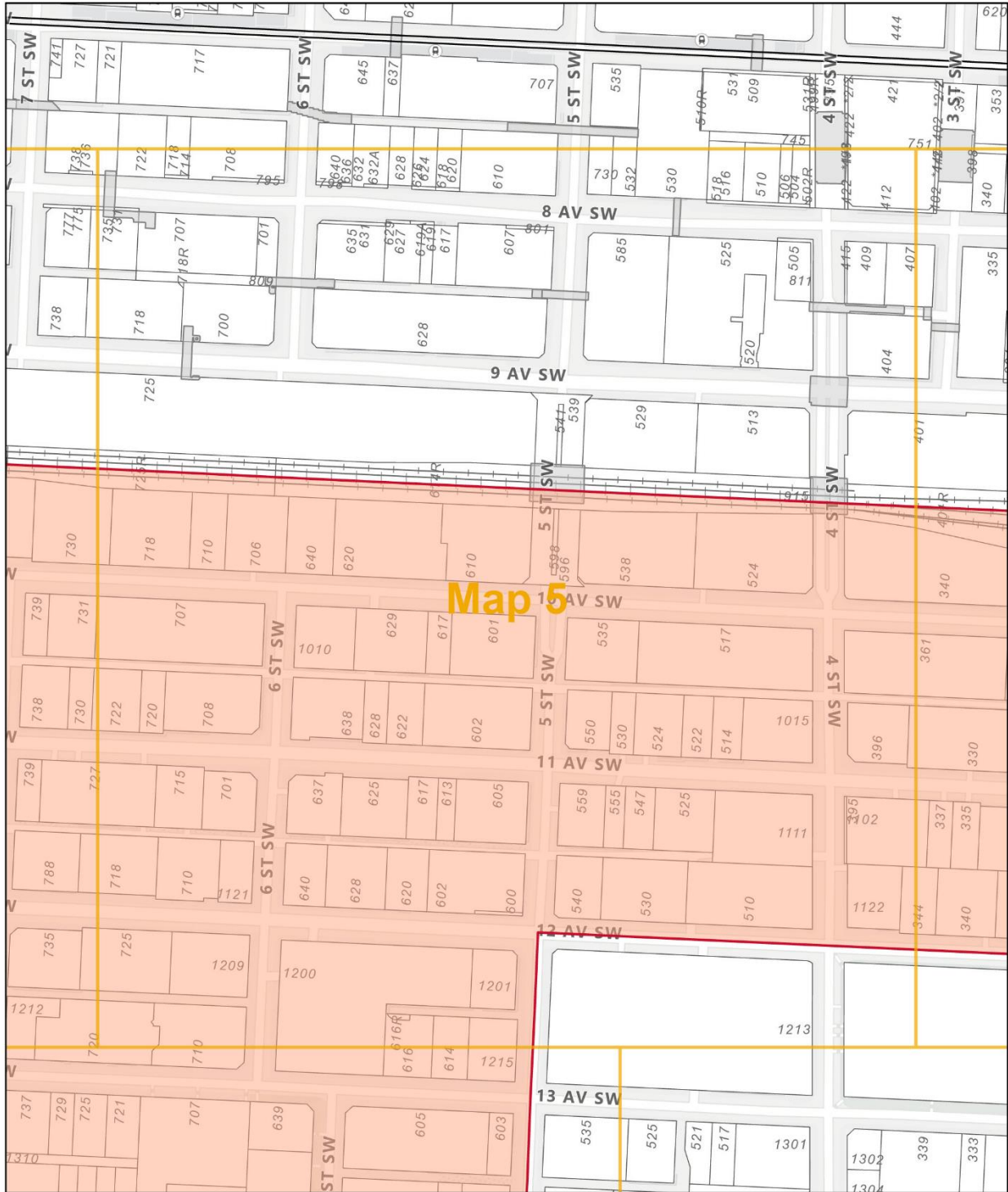



Map 5 - Detail

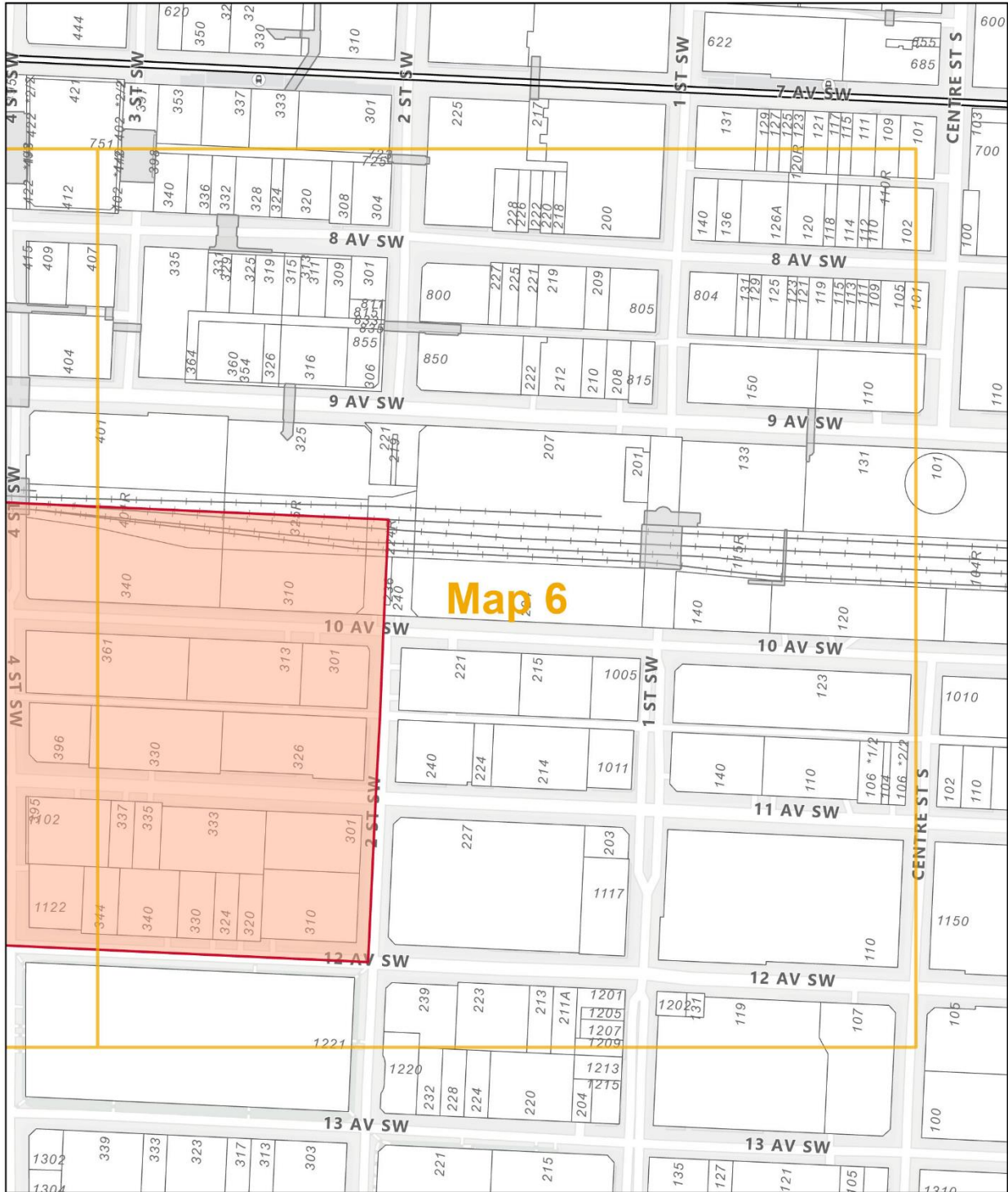

Map 6 - Detail

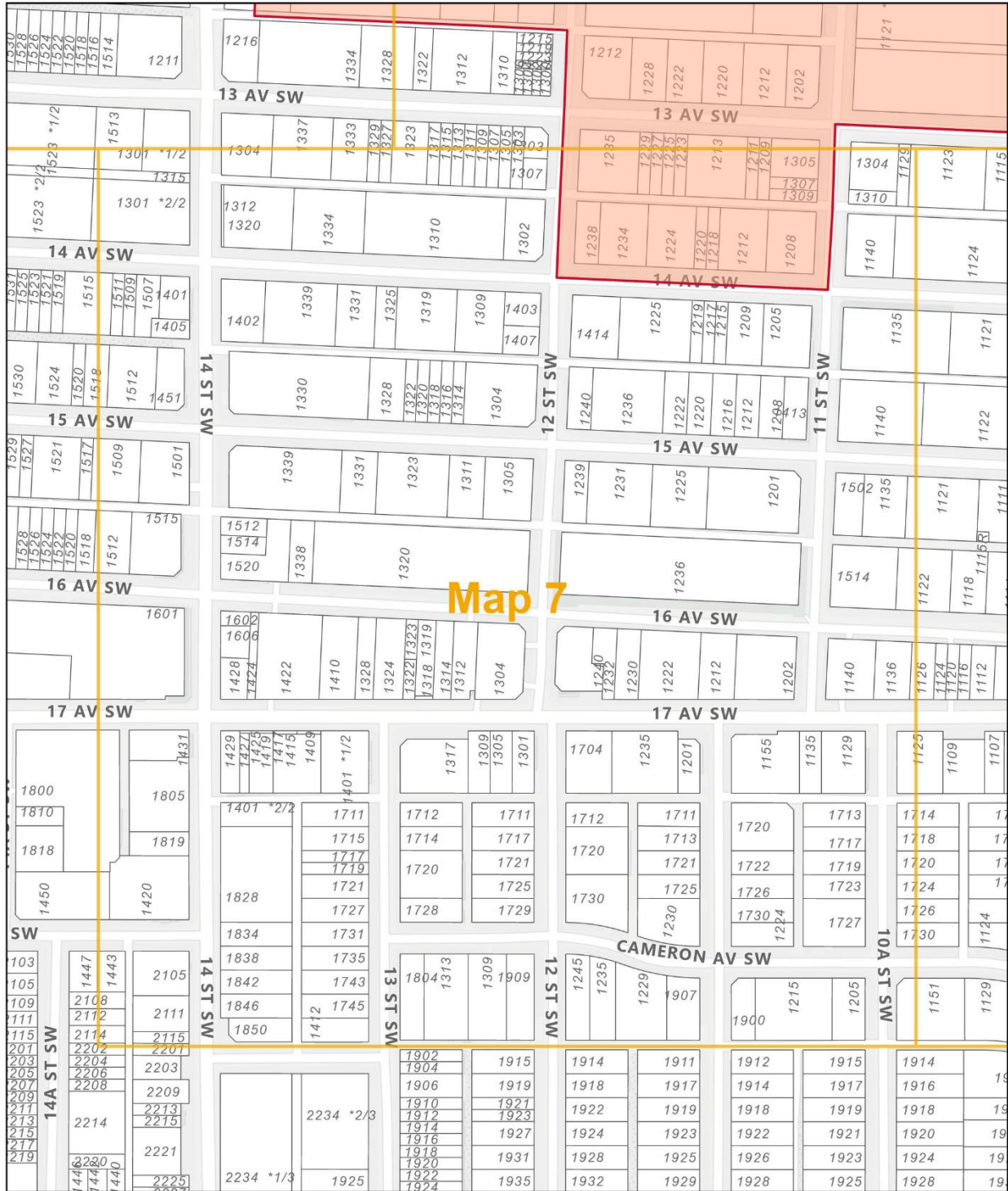

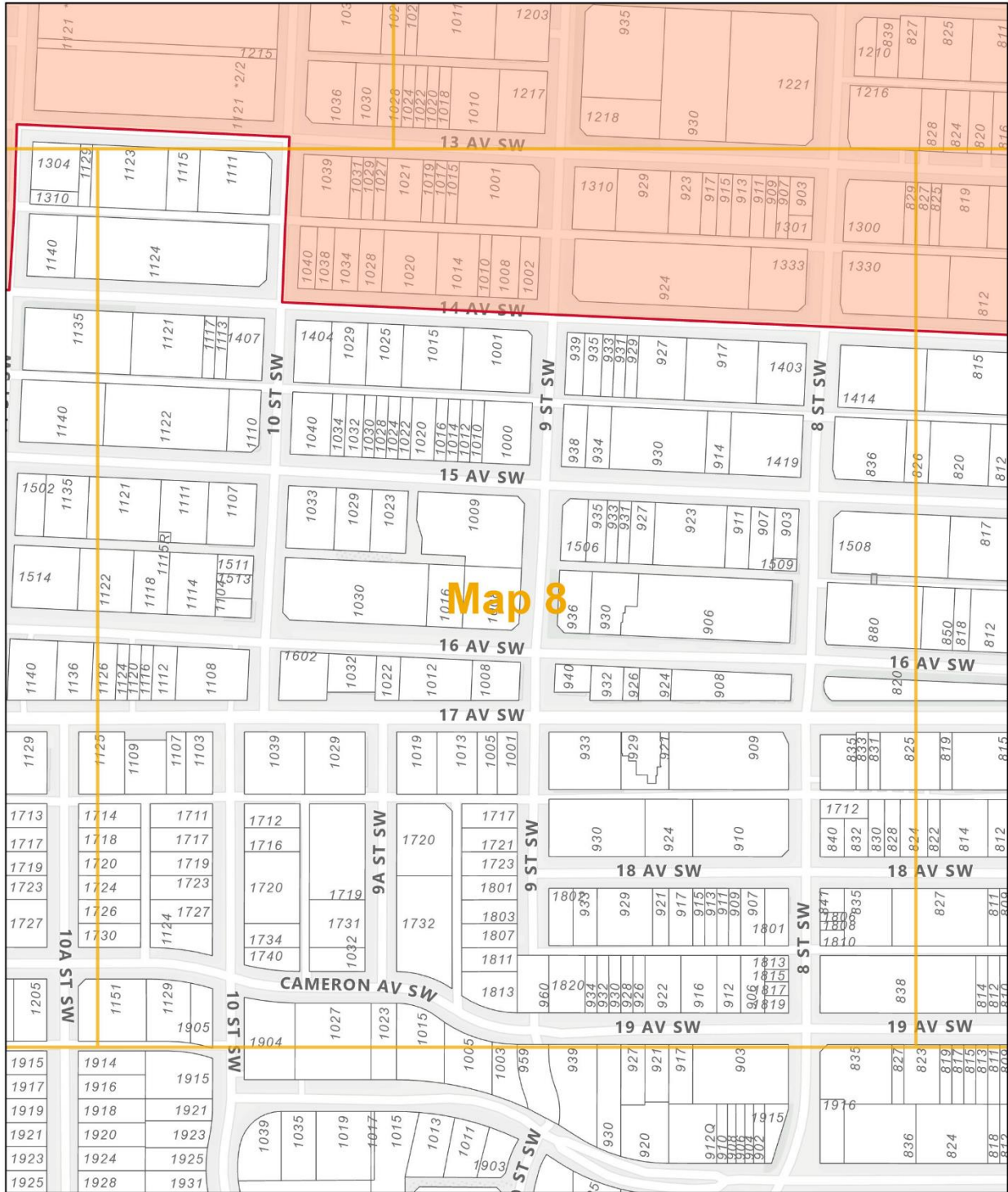

Map 8 - Detail

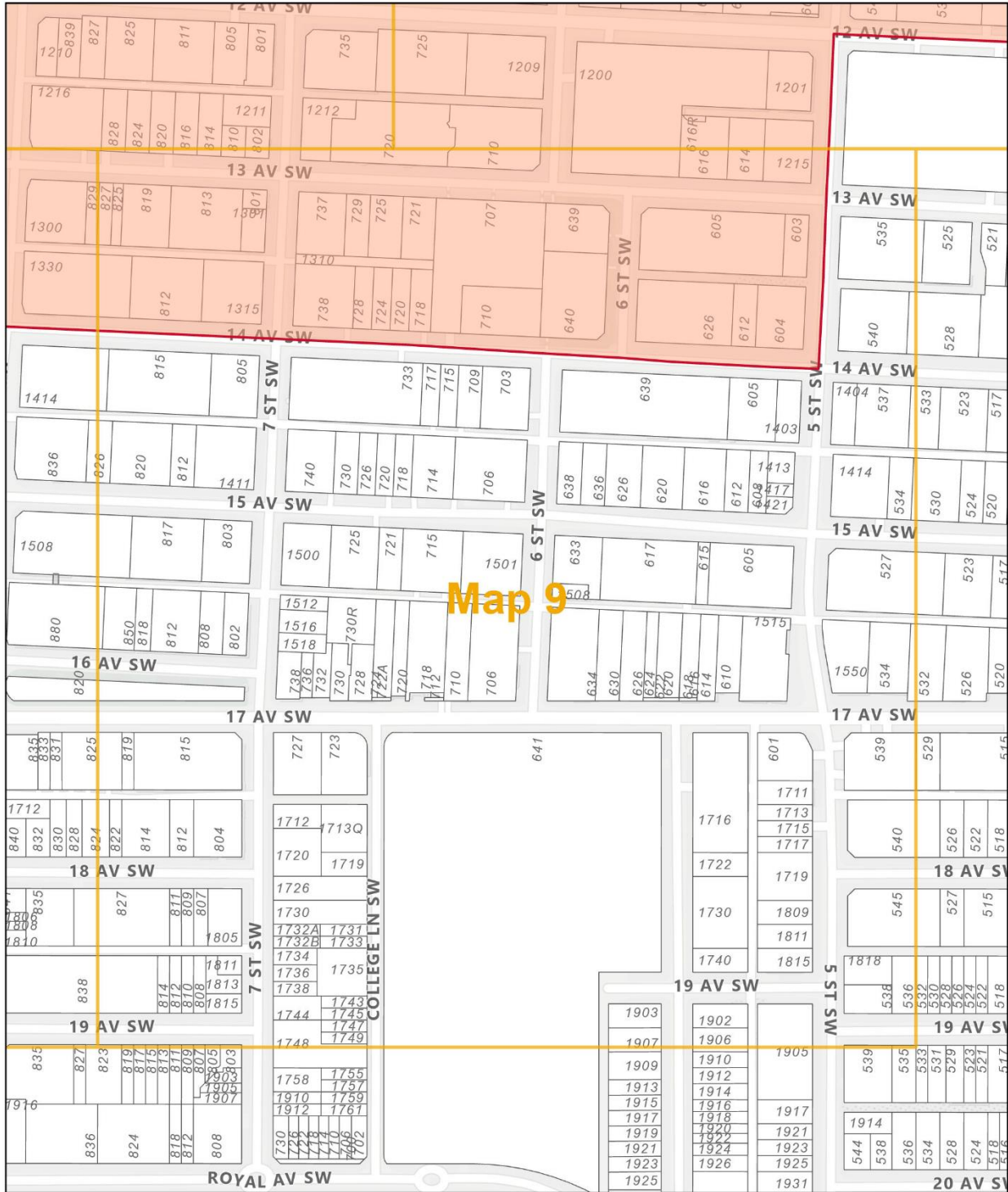
