

**BYLAW NO. 191 - 2025**

Being a Bylaw of The Board of Trustees of Calgary Roman Catholic Separate School Division to provide that voting stations for The Board of Trustees of Calgary Roman Catholic Separate School Division that are located in The City of Calgary, the City of Airdrie, the City of Chestermere, and the Town of Cochrane can open before 10 am.

**WHEREAS** under the *local Authorities Election Act*, The Board of Trustees of Calgary Roman Catholic Separate School Division, The City of Calgary, the City of Airdrie, the City of Chestermere, and the Town of Cochrane are elected authorities;

**AND WHEREAS** under the *local Authorities Election Act*, The Board of Trustees of Calgary Roman Catholic Separate School Division has entered into an agreement with The City of Calgary for the conduct of elections for The Board of Trustees of Calgary Roman Catholic Separate School Division;

**AND WHEREAS** elections for The Board of Trustees of Calgary Roman Catholic Separate School Division can occur at voting stations located in The City of Calgary, the City of Airdrie, the City of Chestermere, and the Town of Cochrane;

**AND WHEREAS** under section 46(1) of the *local Authorities Election Act* every voting station shall be kept open continuously on election day from 10 am until 8 pm; however, under section 46(2) of the *local Authorities Election Act*, an elected authority can pass a bylaw prior to June 30 of a year in which an election is to be held that provides that voting stations are to be open before 10 am;

**AND WHEREAS** The Board of Trustees of Calgary Roman Catholic Separate School Division would like the opening times of the voting stations for The Board of Trustees of Calgary Roman Catholic Separate School Division that are located The City of Calgary, the City of Airdrie, the City of Chestermere, and the Town of Cochrane to be the same as the opening times of the voting stations for The City of Calgary, the City of Airdrie, the City of Chestermere, and the Town of Cochrane in those locations;

**NOW THEREFORE, THE BOARD OF TRUSTEES OF CALGARY ROMAN CATHOLIC SEPARATE SCHOOL DIVISION ENACTS AS FOLLOWS:**


1. This bylaw may be cited as the "Early Opening of Voting Stations Bylaw."
2. Words used in this bylaw have the same meaning as under the *local Authorities Election Act*.
3. If The City of Calgary, the City of Airdrie, the City of Chestermere, or the Town of Cochrane has passed a bylaw that provides that a voting station for that other elected authority is to be open before 10 am, then any voting station for The Board of Trustees of Calgary Roman Catholic Separate School Division that is at the same location as that voting station for that other elected authority is to open at the same time.
4. This bylaw comes into force on the day it is passed.


