Notice of Request to Establish a

**Chinatown District Business Revitalization Zone** 

Please be advised that the City of Calgary has received a request to establish a Chinatown District Business Revitalization Zone (BRZ). You are receiving this letter because your business is located within the boundaries of the proposed BRZ. A copy of the request and a map of the proposed boundaries are attached.

A BRZ is an opportunity for businesses in an area to work together to raise and administer funds to improve and promote their businesses. The role of a BRZ is to:

- Enhance the economic development of an area through promotion and marketing.
- Improve the physical environment of public spaces in commercial areas.
- Develop, improve and maintain public parking.
- Work collaboratively with The City.
- Advocate for policies and practices that support economic vitality in the zone.

The BRZ's operations are funded through a tax levy imposed on all businesses operating within the BRZ.

Business owners within the proposed BRZ boundaries may object to the establishment of a BRZ by petitioning Council. The *Business Revitalization Zone Regulation* (Alberta Regulation 377/94) sets out the following requirements for a petition:

- **4(1)** Persons who would be taxpayers if a proposed zone was established may petition the council objecting to the establishment of the zone.
- (2) The petition is not sufficient unless
  - (a) it is signed by persons referred to in subsection (1) who represent more than 50% of the businesses that would be taxable businesses if the proposed zone was established, and
  - (b) it is filed with the chief administrative officer within 60 days of the last date on which notice of the request was mailed or delivered.

(3) If the chief administrative officer declares a petition to be sufficient, council may not pass a bylaw establishing a business revitalization zone set out in the request until 2 years have passed from the day the petition was declared to be sufficient.

City Council may pass a business revitalization zone bylaw to establish the proposed Chinatown District BRZ if the City does not receive a petition within the time set out in the Regulation.
