





Non-Charter Outputs

Charter ideas deemed good for whole province (e.g. environ.as general purpose; JUPAs)

Proposals rejected by GOA (e.g. Heritage Preservation; Oil and Gas Approvals)

Proposals rejected by Cities (e.g. use of tech in assessment, SDAB)

City of Calgary Charter, 2018 Regulation

- 38 new authorities
- Currently posted for second 60-day review
- Could come into force as early this month
- Retroactive to January 1, 2018
- Most require public hearing before adoption





City of Calgary Charter, 2018 Regulation

- 38 new authorities
- Currently posted for second 60-day review
- Could come into force as early as March 6, 2018
- Retroactive to January 1, 2018
- Most require public hearing before adoption





- Authority to perform supplementary assessments on previously farm land
- Authority to provide electronic assessment notices where citizens opt-in
- Authority to create a municipal tribunal for parking and transit offences
- Greater autonomy over financial administration (i.e. budgeting processes)

Supporting community wellbeing
Smarter community planning
Environmental stewardship



- Authority to offer loans to support affordable housing projects
- Ability to ensure that affordable housing agreements follow title for the life of the agreement

- Authority to make variations to the Traffic Safety Act
- Authority to define a local subdivision process
- Authority to adopt additional types of statutory plans

- Requirement to adopt a climate change adaptation and mitigation plan
- Addition of the environment as it relates to land-use as a matter for bylaws
- Inclusion of the environment in planning and development provisions of MGA

The Charter complements and modifies existing legislation, primarily the MGA

- The MGA says municipalities will, must or shall do certain things
- The charter says that The City of Calgary can, may or might take a range of actions



How does the charter accomplish these changes


Through regulation, a city charter can:

- Add to the MGA or other provincial legislation (i.e. adding additional authority for The City)
- Subtract from the MGA or other provincial legislation (i.e. exempting The City from certain requirements)
- Allowing The City to modify provincial legislation (i.e. enabling The City to legislate)



Once the regulations are in place, then what?

"Before giving second reading to a charter bylaw, the Council of the charter city must hold a public hearing with respect to the proposed bylaw" Section 141.5(4), MGA





Reporting on the Charter

The City will need to keep careful track of its use of the Charter regulation

- Use of the charter regulation effectively amends the MGA, therefore requires transparent accounting for the public and internal and external staeholders
- Charters will need to be reviewed at least every five years
- Public reporting requirements of Charter



What are we doing to prepare?

In addition to providing this and other updates to Council, Intergovernmental & Corporate Strategy is:

- Working with the Law Department, which is leading the process and reporting elements
- Helping BUs to understand the opportunities for, and requirements of, using the charter regulations, and helping prioritize potential changes
- Preparing key messages to share with internal and external stakeholders on the charter's enactment
- Continuing to work with the Government of Alberta and City of Edmonton to monitor charter implementation, and consider future changes
