Disclosure Policy – Real Estate Registry Scope Document

Direction to Administration:

1. Develop a Disclosure Policy for Members of Council;

2. The first required section of this policy addresses real estate holdings **and options on financial investment disclosure**;

3. The breadth of application is limited to real estate holdings of the Member of Council, his/her spouse or adult interdependent partner, and any dependent children, along [with] any companies in which they have a significant interest;

4. Ensure that the policy keeps the property information collected for the registry associated to the relevant Member of Council's family generally, rather than specific individuals;

5. Allow for exact property addresses to be shielded from public viewing, but available to Administration under various privacy provisions under the *Freedom of Information and Protection of Privacy Act,* and further by renumbering the remaining Recommendations accordingly;

6. Arrange for the Registry to be administered by the Manager of the Office of the Aldermen **and Office of the Mayor**, and;

7. Plan for all of the information collected to be available online.
