The management of Sofina Foods Inc. has requested that the Ramsay Residents provide a critique of our experiences with the operations of the Lilydale Plant since they purchased the location.

We had been, for several years prior to Sofina's purchase of Lilydale, very unsatisfied with the management of the plant and had had no success in gaining any improvements.

After the purchase by Sofina Foods Inc. we have been very pleased with the progress that has been made.

Sofina agreed to invest a significant amount of their time and money to address all the concerns that were brought to them.

A Ramsay Advisory Committee was formed that held regular meetings with the Management of Sofina. Improvements to be made were performed based on agreement by the Advisory Committee.

The company investigated all the means possible to reduce the noise and odor concerns that we have had.

They have installed sound barrier fences as well as a barrier on the roof of the building.

An innovative mist is now used to reduce odors. The community is notified when waste removal is to be performed and they do not have removal trucks on a long weekend.

They have made several other improvements and maintain the properties they own to the best of their ability.

They have set up a designated phone line for any resident to call if they have concerns and have attended Ramsay Community Association General Meetings to provide information and to answer questions.
