Report on audited annual financial statements

As agreed in our engagement letter dated November 12, 2013, we have performed an audit of the financial statements of the Calgary Police Service ("the Service") as at and for the year ended December 31, 2013, in accordance with Canadian generally accepted auditing standards ("Canadian GAAS") and expect to issue our audit report thereon dated May 27, 2014.

This report summarizes our findings during the audit. Our audit has been conducted in accordance with the Audit Plan that was presented to the Audit and Finance Committee members at the meeting on November 12, 2013 with the exception of the changes to the Audit Plan as discussed in our report.

Audit scope matters

Canadian GAAS requires that we communicate to the Audit and Finance Committee on the following matters:

Status of our audit	<p>We expect to be in a position to render our audit opinion dated May 27, 2014 on the financial statements of the Service following approval of the financial statements by the Calgary Police Commission and the completion of the following outstanding procedures:</p> <ul style="list-style-type: none">• Receipt of signed management representation letter and update of subsequent events to audit report date;• Receipt of legal letters;• Minor documentation items; and• Finalization of the Engagement Quality Control review.
Audit strategy and scope	<p>The audit planning and the preliminary risk assessment activities we conduct enable us to set the scope of our audit and to design procedures tailored to that scope. Refer to our audit plan communicated on November 12, 2013.</p>
Materiality	<p>Materiality is the magnitude of misstatements, including omissions, in the financial statements that, individually or in the aggregate, could reasonably be expected to influence the economic decisions of the financial statement users. Judgments about materiality are made in the light of surrounding circumstances, and are affected by our perception of the information needs of the financial statement users, and by the size or nature of a misstatement, or a combination of both. We are responsible for providing reasonable assurance that your financial statements as a whole are free from material misstatement.</p> <p>Canadian GAAS requires that we determine performance materiality for the purposes of assessing the risks of material misstatement of the financial statements and determining the nature, timing and extent of our audit procedures. Planning the audit solely to detect individually material misstatements overlooks the fact that the aggregate of individually immaterial misstatements may cause the financial statements to be materially misstated, and leaves no margin for possible undetected misstatements. Performance materiality is set at a lower level than materiality, so that if misstatements are detected, we may nevertheless be able to conclude with reasonable assurance that the uncorrected misstatements both individually and in the aggregate do not exceed materiality.</p> <p>Materiality levels were determined based on a percentage of budgeted operating expenses. For the year ended December 31, 2013 the materiality of \$4,300,000 (2012 - \$3,900,000) was used.</p>

Significant difficulties encountered in performing the audit	We did not encounter any significant difficulties while performing the audit. There were no significant delays in receiving information from management required for the audit nor was there an unnecessarily brief timetable in which to complete the audit.
Changes to the audit plan	The audit was conducted in accordance with our audit plan, which was communicated to the Service on November 12, 2013. Amendments were required to the audit scope and audit approach that we communicated in the audit plan on November 12, 2013. These amendments include additional testing of flood related expenditures, assessment of the valuation of tangible capital assets damaged by the flood, including completeness of impairments, capitalization versus expenditure of repairs and appropriate accounting of The City of Calgary recoveries related to the flood. Further, financial accounting matters related to the flood were tested at a significant risk level.
Management judgment and accounting estimates	Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. These judgments are normally based on knowledge and experience about past and current events, assumptions about future events and interpretations of the financial reporting standards. During the year ended December 31, 2013, management advised us that there were no significant changes in accounting estimates or in judgments relating to the application of the accounting policies.
Disagreements with management	In the course of our audit, we did not encounter any disagreements with management about matters that individually or in the aggregate could be significant to the financial statements.
Consultation with other accountants	Management has informed us that the Service has not consulted with other accountants about auditing or accounting matters.
Legal and regulatory compliance	Management is responsible for ensuring that the Service's operations are conducted in accordance with the laws and regulations applicable to the Service in the jurisdictions in which it operates. The responsibility for preventing and detecting non-compliance rests with management. The auditor is not and cannot be held responsible for preventing non-compliance with laws and regulations. Our limited procedures did not identify any areas of material non-compliance with laws and regulations by the Service.
Post-statement of financial position financial events	Management is responsible for assessing subsequent events up to the date of the release of the financial statements. No post-statement of financial position events have been identified during the course of our audit which would have an impact on the financial statements. We will update subsequent events to the audit report date of May 27, 2014.
Management representation letter	A draft version of the management representation letter to be signed by management is included in Appendix 3.

Independence	<p>We have developed appropriate safeguards and procedures to eliminate threats to our independence or to reduce them to an acceptable level.</p> <p>As required under Canadian GAAS, we have reported all relationships and other relevant matters that, in our professional judgment, may reasonably be thought to bear on our independence. We have provided a draft version of the independence letter we intend to use to confirm our independence for the year ended December 31, 2013, in Appendix 2.</p>
Quality control	<p>Our firm's quality control process embraces each of the elements identified in the CPA Canada Handbook sections covering Canadian standards of quality control for firms that perform audits and reviews of financial statements and other assurance engagements.</p>
Fees	<p>We communicated our proposed audit fees of \$44,000 (2012 - \$44,000), excluding GST and administration fees for the audit. As a result of additional procedures required to audit flood related items not originally contemplated in our audit planning process, additional fees of \$3,000 will be charged in relation to the 2013 audit, which have been discussed with management.</p>
Communications	<p>As a part of our audit plan, we committed to communicate certain matters to the Audit and Finance Committee on a regular basis or as specified events occur.</p> <p>A summary of our communications is provided in Appendix 4.</p>

Audit findings

This following summarizes the main findings arising from our audit

Internal control	<p>We obtained an understanding of internal control relevant to the audit, however not all controls are relevant to every audit. We evaluated the design of controls relevant to the audit and determined whether they have been implemented. We are not, however, required in a non-integrated audit to determine whether all relevant controls are operating effectively. Although not required by Canadian GAAS, we may decide that, for a particular engagement, it makes sense to rely on the effective operation of some controls to determine the planned substantive procedures we will perform.</p> <p>In such cases, we would go beyond evaluating the design of relevant controls and determining whether they have been implemented to also test whether the controls on which we intend to rely are operating effectively.</p> <p>In our audit of the Service's financial statements, we applied a substantive audit approach to testing of account balances and as such, we did not rely on internal controls.</p>
Audit adjustments and uncorrected misstatements	<p>In accordance with Canadian GAAS, we request that all misstatements be corrected. We are required to report all uncorrected misstatements greater than \$215,000 (2012 - \$195,000), which is computed at 5% of materiality and those that are quantitatively insignificant but qualitatively significant, in the appendices attached to the management representation letter.</p> <p>We noted no uncorrected misstatements during the course of the audit.</p>
Unadjusted disclosure deficiencies	<p>In accordance with Canadian GAAS, we request that all disclosure deficiencies be corrected.</p> <p>We have no unadjusted disclosure deficiencies to report to you.</p>
Conclusion	<p>In accordance with Canadian GAAS, our audit is designed to enable us to express an opinion on the fairness of the presentation of the Service's annual financial statements prepared in accordance with Canadian public sector accounting standards ("PSAS").</p> <p>No restrictions have been placed on the scope of our audit. In performing the audit, we were given full and complete access to the accounting records, supporting documentation and other information requested.</p> <p>We intend to issue an unmodified audit report on the financial statements of the Service as at and for the year ended December 31, 2013 once the financial statements are approved by Calgary Police Commission on May 27, 2014.</p> <p>A draft version of our Auditor's report is included in Appendix 1.</p>

Audit risks

Our audit plan presented on November 12, 2013 identified certain areas that we refer to as significant risks. As discussed earlier in this report, financial accounting matters related to the flood were added as an area of significant risk. The results of our audit work on these risks are set out below:

Significant risks and areas of audit focus

Areas of significant risk	Our audit response	Our conclusion
Revenue Recognition and Management override of controls Professional auditing standards require us to presume management override of controls to be risks of material misstatement due to fraud.	Professional auditing standards require us to presume revenue recognition and management override of controls to be risks of material misstatement due to fraud. There is a risk that revenue may not be appropriately recognized and recorded or that management has the ability to override controls. We made selections and perform detailed testing to verify whether it was appropriate to recognize revenue for each revenue stream. To test the risk of management override of controls, we examined journal entries made by the entity against certain fraud indicators and we tested a sample of journal entries for proper authorization. We tested management estimates as well as any unusual or significant transactions. In addition, we gained an understanding of internal controls relating to various financial statement line items.	Overall, we conclude that there were no issues noted relating to revenue recognition and management override of controls in the context of the financial statements taken as a whole.

Areas of significant risk	Our audit response	Our conclusion
Valuation of TCA, including completeness of impairments, capitalization versus expenditure of repairs and appropriate accounting (The City of Calgary recoveries)	<p>The flood caused damages to the basement of the Administration building located in downtown Calgary. We reviewed the impairment to the building as result of the damages caused by the flood and determined the impairment to be immaterial. Certain vehicles were also damaged and were fully written off during the year.</p> <p>We reviewed a sample of expenditures relating to the repair or maintenance of flood damaged assets to ensure that these costs were appropriately treated as an expense or capital item.</p> <p>We reviewed the recognition of recoveries from The City of Calgary to ensure these were appropriately accounted for in the year-end financial statements.</p>	Based on the procedures performed, we conclude that tangible capital assets and The City of Calgary recoveries are not materially misstated in the context of the financial statements taken as a whole.

Areas of audit focus	Our audit response	Our conclusion
Completeness of accounts payable and accrued liabilities <p>The accounts payable and accrued liabilities may be understated due to management not recording liabilities and/or accruals for invoices not yet received.</p>	<p>We reviewed and tested a sample of transactions recorded subsequent to year-end to identify any unrecorded liabilities.</p> <p>We also reviewed Board minutes, unpaid invoices, sent legal confirmations, held discussions with management and relied on our knowledge of the Service to identify any unrecorded liabilities.</p>	Overall, we concluded that accounts payable and accrued liabilities are fairly stated, appropriately classified and properly disclosed in the context of the financial statements taken as a whole.
Accuracy, recording and presentation of reserves	We tested the interest earned on the reserves to verify the amount and rates used were reasonable. We reviewed the expenditures charged to the reserve and vouched a sample of expenditures to invoices to verify that the item was non-recurring and an appropriate charge against the reserve.	Overall, we concluded that reserves are fairly stated, appropriately classified and properly disclosed in the context of the financial statements taken as a whole.
The City of Calgary financing <p>The outstanding debenture and loan balances may be materially misstated.</p>	<p>We reviewed the balance due from The City of Calgary to ensure these balances were appropriately recorded. We reviewed transfer payments received during the year to fund specific projects.</p> <p>We reviewed the related funding agreements to verify that funds are used for their intended purpose and that revenue is recognized in the appropriate period.</p>	Overall, we concluded that the outstanding debentures and loan balances are fairly stated, appropriately classified and properly disclosed in the context of the financial statements taken as a whole.

Areas of audit focus	Our audit response	Our conclusion
Accuracy and disclosure of pension plan liability (employee benefit obligations)	<p>We reviewed the pension plan balance recorded at year end and verified this balance through confirmation with the actuary. We reviewed the financial statement disclosure of the pension liability with the most recent actuarial valuation report prepared and ensured financial statement disclosures were in accordance with accounting standards.</p> <p>We considered the reasonableness and consistency of assumptions used by the actuary. In accordance with Canadian GAAS, we communicated with the actuary in writing regarding our use of and reliance on their report and we assessed the qualification and independence of the actuary.</p>	<p>Overall, we concluded that the pension plan liability (employee benefit obligations) are fairly stated, appropriately classified and properly disclosed in the context of the financial statements taken as a whole.</p>

Accounting practices, judgments and estimates

Adoption of new accounting standards

The following new accounting standards were issued by the CPA Public Sector Accountability Board and are effective for fiscal years beginning on or after April 1, 2012. The Calgary Police Service (the "Service") was required to adopt the new standards effective January 1, 2013:

PS 1201 - *Financial Statement Presentation*
PS 2601 - *Foreign Currency Translation*
PS 3410 (Revised) - *Government Transfers*
PS 3450 - *Financial Instruments*
PS 3510 - *Tax Revenue*

The Service has determined that PS 2601 - *Financial Currency Translation*, PS 3450 - *Financial Instruments* and PS 3510 - *Tax Revenue* do not apply to the Service and as such these standards did not have any impact on the December 31, 2013 year-end financial statements.

PS 3410 (Revised): *Government Transfers* did not have an impact on the December 31, 2013 year-end financial statements as the Service was recording government funding in accordance with the requirements of this section.

PS 1201: *Financial Statement Presentation* requires the Service to include a statement of remeasurement gains and losses as part of the financial statements. Such a statement has not been included as part of the December 31, 2013 year-end financial statements as PS 2601 and PS 3450 do not apply to the Service and as such there are no remeasurement gains or losses incurred.

Management judgment and accounting estimates

In our judgment, the significant accounting estimates made by management are, in all material respects, free of possible management bias and of material misstatement. The disclosure in the financial statements around estimation uncertainty is in accordance with Canadian public sector accounting standards ("PSAS") and is appropriate to the particular circumstances of the Service.

Appendix 1 – Draft version of our Auditor's report

INDEPENDENT AUDITOR'S REPORT

To the Members of the Calgary Police Commission

We have audited the accompanying financial statements of the Calgary Police Service, which comprise the statement of financial position as at December 31, 2013, and the statements of operations and accumulated surplus, statement of cash flows and statement of changes in net financial assets (liabilities) for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian public sector accounting standards, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error.

In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

In our opinion, the financial statements present fairly, in all material respects, the financial position of The Calgary Police Service as at December 31, 2013, and the results of its operations, cash flows and changes in net financial assets (liabilities) for the year then ended in accordance with Canadian public sector accounting standards.

We have been engaged to audit the financial statements of the Calgary Police Service (the “Service”) for the year ended December 31, 2013.

Canadian generally accepted auditing standards (“Canadian GAAS”) require that we communicate in writing with you regarding our compliance with relevant ethical requirements regarding independence as well as all relationships and other matters between the Service, Deloitte and network firms that, in our professional judgment, may reasonably be thought to bear on our independence. Accordingly, we hereby confirm that we are independent with respect to the Service within the meaning of the Rules of Professional Conduct of the Institute of Chartered Accountants of Alberta as of May 27, 2014.

This representation letter is provided in connection with the audit by Deloitte LLP (“Deloitte” or “you”) of the financial statements of the Calgary Police Service (the “Service” or “we” or “us”) as at and for the year ended December 31, 2013, and a summary of significant accounting policies and other explanatory information (the “Financial Statements”) for the purpose of expressing an opinion as to whether the Financial Statements present fairly, in all material respects, the financial position, results of operations, cash flows and changes in net financial assets (liabilities) of the Service in accordance with Canadian public sector accounting standards (“PSAS”).

We confirm that, to the best of our knowledge and belief, having made such inquiries as we considered necessary for the purpose of appropriately informing ourselves:

Financial statements

1. We have fulfilled our responsibilities as set out in the terms of the engagement letter between the Service and Deloitte dated November 12, 2013 for the preparation of the Financial Statements in accordance with PSAS. In particular, the Financial Statements are fairly presented, in all material respects, and present the financial position of the Service as at December 31, 2013 and the results of its operations, cash flows and changes in net financial assets for the year then ended in accordance with PSAS.
2. Significant assumptions used in making estimates, including those measured at fair value, are reasonable.

In preparing the Financial Statements in accordance with PSAS, management makes judgments and assumptions about the future and uses estimates. The completeness and appropriateness of the disclosures related to estimates are in accordance with PSAS. The Service has appropriately disclosed in the Financial Statements the nature of measurement uncertainties that are material, including all estimates where it is reasonably possible that the estimate will change in the near term and the effect of the change could be material to the Financial Statements.

The measurement methods, including the related assumptions and models, used in determining the estimates, including fair value, were appropriate, reasonable and consistently applied in accordance with PSAS and appropriately reflect management's intent and ability to carry out specific courses of action on behalf of the entity. No events have occurred subsequent to December 31, 2013 that require adjustment to the estimates and disclosures included in the Financial Statements.

There are no changes in management's method of determining significant estimates in the current year.

3. We have determined that the Financial Statements are complete as of the date of this letter as this is the date when there are no changes to the Financial Statements (including disclosures) planned or expected. All final adjusting journal entries have been reflected in the Financial Statements and the Financial Statements have been approved in accordance with our process to finalize financial statements.
4. We have completed our review of events after December 31, 2013 and up to the date of this letter. All events subsequent to the date of the Financial Statements and for which PSAS requires adjustment or disclosure have been adjusted or disclosed. Accounting estimates and disclosures included in the Financial Statements that are impacted by subsequent events have been appropriately adjusted.
5. The Financial Statements are free of material errors and omissions.
6. The Service has satisfactory title to and control over all assets, and there are no liens or encumbrances on such assets. We have disclosed to you and in the Financial Statements all assets that have been pledged as collateral.

Information provided

7. We have provided you with:
 - a. Access to all information of which we are aware that is relevant to the preparation of the Financial Statements, such as records, documentation and other matters. All financial statements and other financial information provided to you accurately reflect the activities and expenses of the Service and do not reflect any activities or expenses of any other person or entity;
 - b. All relevant information as well as additional information that you have requested from us for the purpose of the audit; and
 - c. Unrestricted access to persons within the entity from whom you determined it necessary to obtain audit evidence.
8. We have disclosed to you the results of our assessment of the risk that the Financial Statements may be materially misstated as a result of fraud.
9. We have disclosed to you all information in relation to fraud or suspected fraud that we are aware of and that affects the entity and involves:
 - a. Management;
 - b. Employees who have significant roles in internal control; or
 - c. Others where the fraud could have a material effect on the Financial Statements.

10. We have disclosed to you all information in relation to allegations of fraud, or suspected fraud, affecting the entity's Financial Statements and all knowledge of concerns or allegations of potential errors in the selection of accounting policies or the recording of transactions affecting the Service that have been communicated by employees, former employees, or others, whether written or oral.
11. We have disclosed to you all communications from regulatory agencies and all known instances of non-compliance or suspected non-compliance with laws and regulations whose effects should be considered when preparing the Financial Statements.
12. We have disclosed to you the identity of the entity's related parties and all the related party relationships and transactions of which we are aware, including guarantees, non-monetary transactions and transactions for no consideration and participation in a defined benefit plan that shares risks between group entities.
13. We acknowledge our responsibility for the design, implementation and maintenance of internal control to prevent and detect fraud and error.
14. We have disclosed to you all known, actual or possible litigation and claims, whether or not they have been discussed with our lawyers, whose effects should be considered when preparing the Financial Statements. As appropriate, these items have been disclosed and accounted for in the Financial Statements in accordance with PSAS.
15. We have disclosed to you all liabilities, provisions, contingent liabilities and contingent assets, including those associated with guarantees, whether written or oral, and they are appropriately reflected in the Financial Statements.
16. We have disclosed to you, and the Service has complied with all aspects of contractual agreements that could have a material effect on the Financial Statements in the event of non-compliance, including all covenants, conditions or other requirements of all outstanding debt.

 - PS 3510 - *Tax Revenue*

As discussed in Note 1 to the financial statements, there has been no material impact on the December 31, 2013 year-end financial statements for the adoption of the above new standards.

Management's responsibilities

21. All transactions and events have been carried out in accordance with law, regulation or other authority.

Receivables

22. The Service is responsible for determining the appropriate carrying amount of accounts receivable, as well as estimates used to determine such amounts. Management believes that the carrying amounts recorded and disclosed are appropriate.

Government transfers

23. We have disclosed to you all correspondence relating to government transfers that the Service has had with the funding body.
24. We have assessed the eligibility criteria and determined that the Service is an eligible recipient for the government transfers received.
25. We have assessed the stipulations attached with the funding and have recognized the revenue in accordance with meeting the stipulations required.
26. All government transfers that have been recorded as unearned revenue give rise to an obligation that meets the definition of a liability. Those liabilities have been properly recorded and presented in the Financial Statements.

Tangible capital assets

27. Tangible capital assets have been recorded properly and consistently according to the standards in Section PS 3150 - *Tangible Capital Assets*.
28. We have assessed the useful lives of tangible capital assets and have determined all tangible capital assets contribute to the Service's ability to provide goods and services and therefore do not require a write down.

Communicating a threshold amount

29. We understand that the threshold used for accumulating misstatements identified during the year was \$215,000 for purposes of Appendix A. Misstatements below this amount have been considered clearly trivial.
