BYLAW NUMBER 8M86

**BEING A BYLAW OF THE CITY OF CALGARY
TO DIRECT THE CITY'S RETURNING OFFICER
TO PREPARE A LIST OF ELECTORS FOR
MUNICIPAL GENERAL ELECTIONS**

(Amended by Bylaw Numbers 30M92, 61M94, 21M98)

WHEREAS Sections 49 and 50 of The Local Authorities Election Act provide that Council may direct the Returning Officer to prepare a list of electors who are entitled to vote in a municipal general election:

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS
FOLLOWS:**

1. The Returning Officer for the City of Calgary is hereby directed to prepare in the year of a general election a list of electors entitled to vote in City of Calgary local jurisdictions elections.

2. The Returning Officer is hereby authorized to appoint a sufficient number of enumerators to complete an enumeration of the electors in the City of Calgary.

3. The Returning Officer shall provide each enumerator with an identification badge.

4. The Returning Officer is authorized to:

- (a) use an enumeration form based on, and a voting register card in the form of Schedule "A" as may be modified from time to time by regulations passed pursuant to the Local Authorities Election Act in each year that an enumeration of electors is carried out or an election is held.
- (b) make such alterations to the enumeration form and the voting register card as are required to reflect elector qualifications, election ballots and other technical requirements.

5. The enumeration of electors shall be governed by the following procedures:

- (a) An enumerator shall call at each residence in the City of Calgary and complete an enumeration form for each address, recording the name and required particulars of all eligible electors living in the residence.
- (b) Each enumerator shall submit the completed enumeration forms to the Returning Officer who shall have listings compiled in alphabetical and street address order.
- (c) The listing of electors is not available for public scrutiny but an elector is permitted to verify his or her personal information on the listing and the listing is available, in

electronic or paper format at the discretion of the Returning Officer, to any nominated candidate in an impending City of Calgary local jurisdiction election upon signing a form to be prepared by the Returning Officer to the effect that the listing will be used for campaign purposes only and will not be provided to any person for other purposes.

- (d) The Returning Officer shall prepare a voting register card for each eligible elector, as found at the previous enumeration, for each election held by an applicable City of Calgary local jurisdiction.
