#### BACKGROUND

At the 2018 May 1 OPWG Council Committee, Administration committed to draft proposed meeting agendas for future OPWG Council Committee meetings. A plan for upcoming meeting agendas will assist in focusing Council Committee efforts and will allow other Councillors to participate in meetings of interest.

#### **INVESTIGATION: ALTERNATIVES AND ANALYSIS**

Administration has been overseeing a number of bid development activities related to a potential bid for the 2026 OPWG, until the establishment of a Bid Corporation. The OPWG Council Committee was established to provide guidance and direction to Administration's efforts. The proposed meeting agendas have been timed to allow for the Council Committee to provide guidance and direction on key aspects of work in order for Administration to meet the International Olympic Committee's (IOC) deliverables and timelines for the Dialogue Stage of the potential bid for the 2026 OPWG. Given the fluidity of the work and to accommodate the timelines of a BidCo being established. Administration has proposed meeting agendas through until the end of June 2018 (Attachment 1).
