

Agenda 2020 – A big shift

Agenda 2020 Strategic Direction (Dec 2014)

- 40 recommendations approved
- Three pillars of the Olympic Movement: credibility, **sustainability**, youth

Olympic Winter Games Strategic Review (2015)

- Attention on **sustainability**, legacy, host city invitation, & selection process
- Reduce cost and complexity



How Does the IOC Define Sustainability?

“... working in accordance with one’s vision and values that lead to lasting benefits. While legacy is about the outcomes...sustainability is the upfront approach through which negative impacts are minimized and positive outcomes are maximized.”

“...having the ability to make informed decisions that make good business sense for the job in hand and simultaneously taking full account of both immediate and longer-term impacts and opportunities across environmental, social and economic spheres.”



Draft Sustainability Framework

Sustainability Component	Description
Sustainability Policy	<ul style="list-style-type: none"> • Sustainability foundation, commitment by all delivery agencies to shared vision, broad principles, overall strategy, management system for sustainability program
Sustainability Strategy	<ul style="list-style-type: none"> • Goals, objectives, strategies and desired outcomes for priority sustainability elements, along with responsibilities of respective Games partners
Sustainability Implementation Plans	<ul style="list-style-type: none"> • Actions, responsibilities, resource requirements, risks and measurable results to achieve goals, objectives, and outcomes of sustainability Strategy
Sustainability Management System	<ul style="list-style-type: none"> • Systematic approach whereby measurable results of sustainability program will be managed, tracked, reported, adjusted – certified to ISO 20121 standard
Sustainability Governance	<ul style="list-style-type: none"> • Sustainability program responsibility and accountability structure among Games partners for timely decisions, appropriate resource allocation, regular progress review/adjustment, transparent reporting, issue management
Sustainability Reporting	<ul style="list-style-type: none"> • Accurate, transparent, timely public reporting of Sustainability Program accomplishments, challenges, adjustments – using recognized system
Sustainability Engagement	<ul style="list-style-type: none"> • Stakeholder/public engagement processes for communicating plans and activities, receiving input, understanding interests, managing expectations
Sustainable Procurement	<ul style="list-style-type: none"> • Sustainable sourcing program for purchasing goods and services to support sustainability and legacy program objectives and results




Example Sustainability Objective	Leads to	Legacy Outcome
<ul style="list-style-type: none"> LEED Gold design standards for venue and village buildings 		<ul style="list-style-type: none"> High performance buildings for legacy use in sport, recreation, housing (smaller environmental footprint, healthier spaces, lower operating cost)
<ul style="list-style-type: none"> Engage partners in carbon reduction strategies/actions - sport, government, corporate (sponsors/suppliers) 		<ul style="list-style-type: none"> Adoption of new low carbon practices by partners post-Games that result in reduced carbon emissions over the long term
<ul style="list-style-type: none"> New accommodation for athlete and media villages on developed sites near public transportation 		<ul style="list-style-type: none"> Additional affordable housing supply in appropriate areas, near transit

Collaboration: Working together for sustainability opportunities

Sustainability Example: Carbon Emissions

- Calgary 2026: minimize and compensate their 'direct'/'owned' emission; promote low carbon solutions; car pooling; traffic management; promote Calgary Transit use
- City of Calgary: leverage Games communications, education programs to build awareness to promote Climate Resilience Strategy and Action Plans; showcasing Calgary Transit
- Together: intentionally seek ways to encourage lasting behavior changes to build a legacy collaboratively e.g., showcasing technologies

<p>Should Calgary choose to submit a bid (and for the bid to be successful), sustainability must be fully integrated into the Games' planning and delivery.</p>	<p>The Draft Sustainability Framework is being developed to ensure that sustainability is fully integrated into the 2026 OPWG bid planning and delivery.</p>
<p>Games fail to deliver on sustainability commitments made in the Host City Contract or other agreements.</p>	<p>The Draft Sustainability Framework is being developed with input from many stakeholders. Ensuring commitment and buy-in from stakeholders along with adequate resources will ensure that sustainability commitments are delivered.</p>
