

## Taxi Limousine Advisory Committee

**Terms of Reference:** To provide advice and recommendations to Council to ensure high quality taxi and limousine services and to create and maintain a sustainable industry as specified in Bylaw 6M2007. The objective is to ensure public safety, service quality and consumer protection for customers and service providers. The TLAC will follow the direction of Council by responding to Council requests and making recommendations to City Council.

The Chair of TLAC shall be appointed by Council from the five representatives of the General Public

Voting Members appointed by resolution of Council shall:

- Represent 1 of the categories identified by Council
- Be at least 18 yrs of age
- Be a resident of The City of Calgary
- Not be a member of the Licence Appeal Board or the City of Calgary Administration
- Abide by pecuniary interest requirements

Non-Voting Members:

- Represent 1 of the categories identified by Council,
- Be at least 18 yrs of age
- Not vote on motions before TLAC,
- Not be a member of the Licence Appeal Board,
- Abide by pecuniary interest requirements

Any of the following skills & experience would be an asset for advisory committee members:

- 3 to 5 yrs experience as a board member
- Conflict resolution training or experience
- Policy & public administration knowledge
- Budget planning & financial management experience
- Research & analysis experience
- Good verbal & written communication skills

**Term:** Each member is appointed for a 2 year term, effective the date of the annual Organizational Meeting of Council, with a maximum of 2 consecutive terms. To ensure business continuity, appointments will be staggered by appointing up to eight members annually. A member may resign at any time upon written notice to City Council, and Council may, by resolution, remove any member.
