This email is to advise you that you will be receiving an original hardcopy of a petition circulated amongst nearby residents of the above mentioned location. The reasons that the signees object to the re-designation of 826 16th Street N.W. are as listed below. These are frequently repeated themes voiced to me by residents on their doorsteps:

- Desire to keep area as RC-2 and that re-designation unduly changes the character of the immediate neighbourhood.
- The vast majority of land owner/occupants have bought into our area under the sincere belief that dense, multi-family developments would be confined to existing multi-family zoning and/or former commercial or multi-use sites.
- There is a prevailing opinion that respectful densification of our city is a process with merit. The signees feel that the community of Hillhurst/Sunnyside has done plenty of heavy lifting on this matter, given that current and proposed dense projects will add an estimated 1200 new dwellings to our community in the next few years if all go ahead as proposed.
- 30 residences were canvassed. One resident did not have a problem with re-designation and declined to sign. One resident declined to sign as they felt they lacked sufficient knowledge. One resident declined to sign as they were in the process of selling their home and felt it would be inappropriate to comment. Twenty seven residents signed the letter of opposition.
- Only 6 residents were aware at the time of signing that there was a proposed zoning redesignation for this site. Most who saw the sandwich-board posting thought it was a development permit for a single or semi-detached proposal. Comments about poor notification on the City's part were common. Some suggested that posting of the site should have been done on all sides that are visible to the public.
