
COMMISSIONERS' REPORT TO COUNCIL

C94-137 PROCEDURES FOR INCAPACITATED VOTING

ISSUE:

To fix hours for taking incapacitated electors' votes at home.

RECOMMENDATION:

That Council, under Section 79(1) of the <u>Local Authorities Election Act</u> (LAEA), approve a resolution fixing the hours for taking the vote of an incapacitated elector at his/her home as 10:00 a.m to 7:30 p.m. on election day.

BACKGROUND:

Section 79 of the LAEA provides for incapacitated electors voting at his/her home. Under Subsection (1) Council must, by resolution, fix the times for voting if held outside of the advance voting hours.

On 1989 September 05, Council approved the recommendations in Commissioners' Report C89-90, which fixed the hours for incapacitated voting at 10:00 a.m. to 4:00 p.m. on election day.

RECENT DEVELOPMENTS:

The Returning Officer receives requests for incapacitated voting past 4:00 p.m. on election day for many reasons (e.g. an elector who finds the voting station is inaccessible to a wheelchair).

Also, it is not always possible to accommodate an elector's request prior to 4:00 p.m. due to other commitments of the elector such as medical appointments.

CONCLUSION:

It is advisable to extend the hours for the taking of votes of incapacitated electors. With a cut-off of 7:30 p.m., sufficient time remains to return to the election office to start vote counting at 8:00 p.m..
