RE: East Stoney ASP - Request for Community and Street Name Approval

Please accept this letter on behalf of the landowners as the formal application for the proposed community and related street names for "Homestead" pertaining to all lands located in the East Stoney Area Structure Plan, as adopted by Calgary City Council on May 8, 2017.

We request that the previous community and street name application submitted by Urban Systems in February 2018 for the name "Stevenson" be rescinded. In its place, we are applying for the proposed community name "Homestead" to be applied to the community area identified as in the East Stoney ASP, and which is bounded as follows:

- By the future Airport Trail interchange to the north
- By 84th Street NE and the city limits to the east
- By Stoney Trail to the west; and
- By the future 64th Avenue flyover to the south.

The rationale for the selection of the name Homestead is that it respects past and future pioneers, as Homestead is sure to become the multi-cultural new community founded by people from many different backgrounds and origins around the world, as has been the case in Alberta for close to 150 years.

There is an outline plan expected to be at CPC in July 2018 (LOC 2017-0111) for these lands. If supported by Council, the new community name of Homestead will be applied to this area, along with the associated street names listed below. A review of existing and proposed community names within Calgary and adjacent municipalities showed no conflicts with any similar names
