Consolidating the Safety Codes Permit Bylaws

EXECUTIVE SUMMARY

Currently, the rules and fees for building, mechanical, plumbing, gas, and electrical permits are found in three different bylaws. The intent of the proposed bylaw is to have one single bylaw that is easy to understand and eliminates duplication of rules already found in the provincial regulations which govern safety related permits.

Should Council approve the proposed bylaw, the result will be a single bylaw instead of three and the permit fees will be removed from the bylaw and placed into the planning fee schedule along with all other planning related permit fees.

ADMINISTRATION RECOMMENDATION:

Administration recommends that the Standing Policy Committee on Planning and Urban Development recommends that Council:

- 1. Give three readings to the proposed Safety Codes Permit Bylaw; and
- 2. Repeal the following bylaws:
 - i. Safety Codes Permit Fee Bylaw 63M94
 - ii. Calgary Building Permit Bylaw 64M94
 - iii. Electrical Permit Bylaw 46M2014

RECOMMENDATION OF THE SPC ON PLANNING AND URBAN DEVELOPMENT, DATED 2018 SEPTEMBER 13:

That Council:

- 1. Give three readings to proposed Bylaw 39M2018, Safety Codes Permit Bylaw; and
- 2. Repeal the following bylaws:
 - i. Safety Codes Permit Fee Bylaw 63M94
 - ii. Calgary Building Permit Bylaw 64M94
 - iii. Electrical Permit Bylaw 46M2014

PREVIOUS COUNCIL DIRECTION / POLICY

Although Council did not provide specific direction, the proposed bylaw does align with Council direction to integrate service delivery by providing services in a coordinated and integrated way and to continually improve the customer experience.

BACKGROUND

Presently, The City of Calgary has three separate bylaws which deal with permits associated with building construction:

- 1) Building permits (includes mechanical equipment): Calgary Building Permit Bylaw 64M94;
- 2) Electrical permits: *Electrical Permit Bylaw* 46M2014;

3) Plumbing and gas permits: Safety Codes Permit Fee Bylaw 63M94.

The three bylaws set the fees and provide rules for submitting plans as part of a permit, as well as rules regarding cancellation or extension of permit terms and other specifics. Some of the bylaw provisions are unnecessary as they reproduce provisions found in the Alberta Safety Codes Act, and/or the Alberta Permit Regulation. Additionally, the three bylaws are not completely aligned with each other, which can cause inconsistency in terms of the rules governing different types of permits (ie, a building permit versus a plumbing permit).

INVESTIGATION: ALTERNATIVES AND ANALYSIS

The main objectives for the consolidation of the three bylaws are to remove provisions that are redundant to provincial regulations; combine all necessary information about construction permit fees in a single bylaw; and simplify the fee review and approval process.

By having a single consolidated bylaw that regulates permits issued for construction in the building, electrical, plumbing and gas disciplines, there will be consistency in the application of permit rules for customers.

The proposed bylaw will no longer include a fee schedule. The fee amounts will be part of the planning application fee schedules and fees will be **approved** by Council during the One Calgary Service Plans and Budgets process.

Stakeholder Engagement, Research and Communication

Based on the results of Planning & Development's 2015 customer survey and focus groups, as well as interviews with industry representatives, customers expect a predictable, consistent experience, a simple process, and a clear understanding of what's required in their application. The proposed Safety Codes Permit Bylaw consolidation achieves these expectations.

The research for the proposed Safety Codes Fee Permit Bylaw entailed a review of the Alberta Safety Codes Act, the Alberta Permit Regulation, and comparable bylaws including Edmonton's Safety Codes Permit Bylaw.
