<u>NOTE:</u>	Third reading of Bylaws 38P2015 (area redevelopment plan amendment) and 179D2015 (land use amendment) was withheld and the applicant was directed to seek conditional approval from Calgary Planning Commission for a Development Permit on the subject site. This tabulation is to advise that on 2018 October 4, Calgary Planning Commission recommended approval of the development permit subject to Council giving third reading of Bylaws 38P2015 and 179D2015, and this has therefore met Council's direction for a conditional approval.
