| Recommended Capital Project Description Executive summary Expected Key Deliverables | | Montgomery Community – missing link pathway (DIGC Project)To help implement the Council-approved 2001 Calgary Pathways & Bikeways Plan, this is one of the critical missing link pathways that are needed to connect gaps between pathway routes and between pathways and on-street bikeways within and between communities. Further this plan helps realize the vision for pathways as a recreation and transportation network throughout the city.The construction of a new pathway along the north side of the Bow River, south of 16th AV NW to existing pathway that currently ends at Shouldice Park football fields an connects to the remainder of the river pathway network through downtown. This work creates roughly 10 direct jobs for between 1-6 months, and indirectly supports an extensive City-wide connected pathway system that can be used for recreation, exercise, and transportation year-round, contributing to promoting Calgary as a city where people want to live. | | | | | | | |
