### **Context & Objectives**

#### Context

Under the Alberta Weed Control Act, dandelions are not considered to be a weed, so there is no provincial requirement to control dandelions. The City takes an integrated pest management approach to manage weeds (including dandelions) through various techniques to encourage healthy grass/turf growth.

In June 2015, a Notice of Motion (NM2015-12) was brought before Council to re-evaluate The City of Calgary's dandelion control policy.

During the 2016 season, The City piloted several alternative dandelion management techniques, to understand the effectiveness, costs and resource requirements for each technique.

The evaluation also required public opinion regarding dandelion control.

#### Objectives

The objectives of the public opinion survey were to measure citizens' opinions about dandelion control in Calgary, including:

- Overall opinions about the importance of dandelion control on public and private property
- Overall opinions about individual and City responsibility regarding dandelion control
- Awareness of and familiarity with non-traditional methods of dandelion control
- Attitudes and opinions about the pilot techniques
- Communication and education needs



### **Research Methods**

#### **Data Collection**

- 500 telephone interviews were conducted with Calgary residents.
- Interviews were conducted between August 15th and August 19th, 2016.

#### **Target Respondents**

- Residents of Calgary proper
- Aged 18 or over

#### **Statistical Reliability**

- Margin of error is ±4.4%
- Results are weighted by age, gender and city quadrant to ensure accurate representation

#### Data Analysis & Reporting

- Results from the survey were cross-tabulated to identify notable differences between the following sub-segments of the population.
  - Age
  - Gender
  - Quadrant
  - Communities with Special Tax for Boulevard / Enhanced Landscape Maintenance
  - Homeowners vs. Renters
  - Households with children vs. Households without
  - Households with outdoor pets vs. Households without
  - Satisfaction with the presence of dandelions in the city
- Differences that are significant and meaningful are noted throughout the report.


### Familiarity with Dandelion Control in Calgary

- Most Calgarians consider themselves unfamiliar with what The City is doing to control dandelions in the city. Calgary homeowners tend to
  rate themselves as more familiar, while renters tend to rate themselves as less familiar.
  - Among the minority who do consider themselves familiar with what The City is doing to control dandelions, the most common perception is that The City sprays chemicals to manage them, followed by the belief that The City does very little or nothing at all to manage them. Those who hold the latter belief tend to be those who are less satisfied with the presence of dandelions in Calgary.
  - Calgarians tend to think that The City does not use cosmetic pesticides, except perhaps in sports fields or major parks throughout Calgary.
  - Citizens are largely unfamiliar with the specific techniques The City uses to control dandelions, with less than half rating themselves familiar with any of the techniques. Familiarity is highest for spraying herbicides (45%) and hand-pulling (45%), followed by having goats eat the dandelions (37%). Awareness of the goats is higher among Calgary females and pet owners.
  - The general lack of familiarity with efforts to control dandelions in Calgary, taken together with the small likelihood for citizens to seek information about dandelion control, suggests a lack of interest in this issue among the majority of the population. Note, however, that there is a small minority who are informed about this topic; and they also tend to be more bothered by dandelions, more dissatisfied with the presence of dandelions and more likely to seek information than those who are less informed. It is this latter group that The City may wish to target with communications.

# Calgary

### **Satisfaction with Dandelions in Calgary**

- Satisfaction with the presence of dandelions is divided fairly evenly among dissatisfied (38%) and satisfied (34%) citizens.
- Satisfied citizens tend to either believe that there are "no dandelions" in Calgary, or simply don't mind dandelions. These citizens tend to be younger, and renters. They also are more likely to agree that The City should spend budget on other priorities. They want The City to either keep doing what they've been doing to control dandelions, or do nothing at all. Above all, they want The City to use a method that is least harmful to the environment.
- Dissatisfied citizens, on the other hand, believe that dandelions are "everywhere" in Calgary, and specifically in parks and public spaces. This group tends to be older, retired, and homeowners. They are also more likely to agree that dandelion is a weed that should be controlled, and that dandelions are a problem on properties adjacent to their own. They want to see The City be more proactive about dandelion control, and to "spray more" in general. This group of dissatisfied citizens is divided on which method The City should use to control dandelions, with roughly equal proportions who prioritize "most effective at reducing dandelions" (37%) and "least harmful to the environment" (35%), with the remainder looking for the "most cost-effective" method (24%).
- There is a notable proportion of Calgarians who are dissatisfied with the presence of dandelions in the city, and it will be important for The City to focus on this group's most pressing concern, which is the presence of dandelions on or near their own property. It will also be important for City communications to emphasize any techniques that The City is using that are both environmentally friendly, and effective at reducing dandelions.




Q4. Whether or not you know what The City of Calgary is doing to control dandelions, how satisfied are you with the presence of dandelions in Calgary?

# **Importance of Dandelion Control**

Importance of dandelion control in various areas of the city...



- NET
  - Most Calgarians feel that dandelion control is important on their own property, and on property adjacent to their own. This sentiment is stronger among older citizens and those who are dissatisfied with the presence of dandelions in the city.
  - Many citizens also think that dandelions should be controlled in areas like sports fields, neighbourhood parks, major city parks and playgrounds. Pet owners are less likely to consider it important to control dandelions in neighborhood parks.
  - Calgarians are divided as to whether or not dandelion control is necessary along roadways; while on the other hand they do not think that dandelion control is important in natural areas such as Nose Hill Park and Edworthy Park.



### **Personal Steps Taken to Control Dandelions**

#### Actions taken by homeowners to control dandelions



- Most Calgarian homeowners are doing something to control dandelions on their property, most commonly digging them up by hand.
- Herbicides, mowing, pesticides and unspecified spraying are common among approximately one-in-ten households; while roughly the same proportion controls dandelions through a third-party contractor.
- About one-in-ten Calgary homeowners do nothing to control dandelions on their property.

### • With one notable exception, all of the proposed techniques to control dandelions are very acceptable to Calgarians.

- The most acceptable techniques are the naturalization techniques; having goats eat the dandelions; and experimenting with different, hardier grasses.
- The least acceptable technique is spraying herbicides, which is not acceptable to just over one-third of citizens.
- When forced to choose the best among all nine techniques presented, citizens choose spraying non-chemical weed killer, using goats to control dandelions, and spraying herbicides (shown on the following page).
- Note that spraying herbicides is the least acceptable method, yet it is still preferred (particularly among those dissatisfied with dandelions in Calgary). This may be because of greater familiarity with the technique, the belief that this is what The City is already doing, and the perceived effectiveness of this method.
- Above all, Calgarians want The City to use a method that is least harmful to the environment (shown on the following page). Taken together with other findings in the study, the most promising techniques in public opinion may still be naturalization and using non-chemical weed killer. The challenge for The City will be to make citizens more familiar with these techniques and their effectiveness.





### **Recommended Approach to Control Dandelions**

### Citizens' Opinions of what The City should do to control dandelion growth in Calgary



- Citizens offer various opinions on what The City should do to control dandelion growth in Calgary, with no single method coming through strongly.
- Over one-in-ten Calgarians provide no recommended approach to control dandelions, while the most common suggestions are generic, such as "be proactive," "keep doing what you're doing," and "don't do anything." These are all further evidence that dandelion control is not a priority for the general public.
- The more specific comments echo some of the other findings in the study, and relate to using environmentally friendly techniques, or focusing on specific areas in the city.

### **Attitudes toward Dandelions**

- Attitudes toward dandelions are mixed, with further analysis suggesting that dandelions are more tolerable among younger Calgarians, renters, and those who prefer that The City use techniques that are least harmful to the environment. There are no notable differences among other subgroups.
- Calgarians demonstrate several attitudes that suggest dandelions are problematic.




