



#### **INVESTIGATION: ALTERNATIVES AND ANALYSIS**

The rationale for the selection of the name Homestead is that it pays respect to past and future pioneers. The vision is that Homestead will become a multi-cultural new community founded by people from many different backgrounds, as has been the case in Alberta for close to 150 years.

## Stakeholder Engagement, Research and Communication

The subject application was circulated to various City of Calgary business units and other agencies for review. No objections to the Community name of Homestead were received. No significant concerns were identified for proposed roadway names except for the roadway of Homestead. Addressing identified a concern with there being a Homestead Road in Bragg Creek. Homestead Road is a small gravel road in Bragg Creek, over 80 kilometers away from the proposed Community of Homestead. The probability of confusion over a Homestead Road within the Homestead community would be highly unlikely.

Calgary 911 identified 5 roadways using the name Homestead within the Homestead Acres Mobile Home Park in High River AB. (Homestead Bay, Homestead Way, Homestead Close, Homestead Place and Homestead Trail.) These existing roadways in High River are over 75 kilometers separated from the proposed Community of Homestead. Calgary 911 does not have any objection to the proposed street names.
